On February 10, 2016, Public Employees for Environmental Responsibility (PEER) submitted a Freedom of Information Act request to the Theodore Roosevelt National Park (TRNP) regarding wireless telecommunications towers and antennae in TRNP. [Attachment 1] Specifically, we requested the following:

1. The SF-299 written application submitted by Verizon to construct a new cell tower on land inside TRNP (as required by RM-53, Special Park Uses, Rights-of-Way, Wireless Telecommunication Facilities, Appendix 5, Exhibit 6, Page A5-48).

According to Page A5-49 of the section of RM-53 cited above, the SF-299 must contain all of the following:

"full description of the requested land or facility use in the park, including... equipment and antennas (including structures) to be located at each site."

"maps showing the 'before' and 'after' service levels and signal strength for the proposed WTF site."

"maps showing all other WTF sites and their coverage operated by the applicant up to a 15 mile radius (or other distance determined appropriate by the superintendent)."

"propagation maps from the applicant showing its proposed buildout of sites within a 15 mile radius of the proposed site within the next five years (or other distance or time frame determined appropriate by the superintendent).

a "copy of the FCC license authorizing the applicant to provide wireless telecommunications services for that area, along with a map showing the boundaries of the authorized service area and the relationship of that area to the park's boundaries; and

a "realistic photo-simulation acceptable to the park depicting what the proposed WTF(s) and access, if applicable, would look like after installation."

- 6. A copy of the Federal Register notice alerting the public that an Environmental Assessment (EA) had been issued by TRNP on Verizon's proposal to construct a cell tower inside the boundaries of the park, and that a 30-day public comment period had been initiated. (See RM-53,... Page A5-53)

A copy of the notice published in "a newspaper of general circulation in the affected area and/or in the nearest metropolitan area newspaper" alerting the public that an EA had been issued by TRNP on Verizon's proposal to construct a cell tower inside the boundaries of the park, and that a 30-day public comment period had been initiated. - 8. A copy of the Park's "Administrative Record" documenting all work related to Verizon's SF-299. (See RM-53, Page A5-50)

- 10. All comments received by the Park during the scoping public comment period that ended on January 9, 2015. This request includes comments received on the Park's social media sites.

Note that these final two items were first requested of TRNP under FOIA by PEER more than a year prior on February 6, 2015. [Attachment 2] TRNP did not provide an official acknowledgement of either request after receipt and no reference numbers were supplied.

On March 4, 2016, TRNP provided a partial response to the request, indicating that it was specifically responding to the 2016 FOIA request sections (9) and (10) and indicating that it had received the 2015 FOIA request. [Attachment 3] At that time, TRNP stated that it intended to review the remaining requested materials and provide an Interim Response by April 8, 2016.

On April 29, 2016, we requested an update from TRNP as to the status of their response to the 2016 request sections (1)-(8). [Attachment 4] However, no further communications from TRNP have been received. At present, TRNP has failed to provide Verizon's written application for the construction of a cell tower, the Park's official response, and documentation related to several subsequent notice and review proceedings.

As these responsive materials have not been produced within the statutory deadlines of FOIA, nor is there an identified timeline for the production of these remaining responsive documents, these materials have been constructively denied to us. By this letter, PEER is therefore appealing this constructive denial.


