**REQUEST FOR REVIEW RESPONSE**

Dear Mr. Ibrahim:

This letter is in response to your request for a review of the decision to deny your request for refugee resettlement to the United States. Your request was thoroughly considered, as were the entire contents of your case file. Furthermore, the reviewer also carefully studied any relevant country conditions materials in order to understand your situation. After this thorough review, the following decision has been made:

1.  **APPROVAL FOR REFUGEE RESETTLEMENT** -- After careful consideration, the denial of your request for resettlement to the United States, dated \_\_\_\_\_, is hereby overturned and you are now conditionally eligible for resettlement, pending all necessary medical clearances, security clearances, and other required procedures.
2.  **RE-INTERVIEW** – Your request for review raises important issues that must be resolved before a determination can be made. It is necessary to schedule an interview with you to obtain further information. You will be contacted in the future with the time and date of the interview appointment.
3.  **DENIAL OF REFUGEE RESETTLEMENT** - After careful consideration, the denial of your request for resettlement to the United States, dated November 1, 2010, remains in effect for the reason(s) indicated by check mark below. As a result of this decision, your case will be closed and no further action will be taken.
  - Your request for review did not contain any new information or an allegation of error in the adjudication of your claim.
  - In your request for review, you alleged that the determination to deny your request for refugee status was made in error. Although there could be instances where an error is made during the adjudication of a request for refugee resettlement, the error must be a significant factor in the denial determination in order for the denial to be overturned. However, in your case it has been determined that there is no significant error that would warrant overturning the adjudicating officer's decision.

- In your request for review, you allege that there is new information that supports your claim for refugee resettlement. However, together with the information that you had previously provided, the new information is insufficient to support your application for refugee resettlement.
  - In your request for review, you offered new information of events that occurred prior to the time of the initial United States Citizenship and Immigration Services (USCIS) interview; however, you have failed to provide a reasonable explanation why you did not provide the information at the initial USCIS interview.
4.  **REQUEST FOR REVIEW REJECTED** - After careful consideration, the denial of your request for resettlement to the United States, dated \_\_\_\_\_, remains in effect as your request for review was rejected for the reason(s) indicated by check mark below. As a result your case will be closed and no further action taken.
- Your request for review was rejected as you did not submit your request within 90 days of receiving your decision nor did you provide a reasonable explanation for why your submission fell outside of the deadline.
  - Your request for review was rejected as you have previously submitted a request for review. USCIS will only adjudicate one request for review per case.
