# Here is my most recent and complete biography:

Born in Des Moines on October 29, 1969, Matt grew up in Ankeny. Matt's mom and dad, Ed and Mary, have lived in the same house since 1972. Ed and Mary Whitaker both grew up in Keokuk, Iowa. Ed sells video boards to large arenas and stadiums and Mary is a former elementary school teacher. Matt's only sibling, his brother Todd, is fitness professional and writer in California.

Matt was an adventurous child growing up, exploring the woods and country around his rural home outside of Ankeny. Matt has many great memories of his classmates and teachers at Southeast Elementary School, Nevelyn Junior High School, Parkview Junior High School and Ankeny Senior High School. Matt graduated from high school in 1988. Matt was homecoming king his senior year and captain of the football team.

Matt excelled both athletically and academically at Ankeny. Matt lettered 9 times in 4 sports (football, basketball, baseball and track), was a first-team all-state football player and a first-team all-conference football and baseball player. Matt graduated in the top 10% of his high school class.

Matt received an athletic scholarship from Coach Hayden Fry and the University of Iowa. At Iowa, Matt played in 35 consecutive games during his Sophomore, Junior and Senior years, lettering all 3 years he played. Matt was a three-time academic all-Big Ten selection and an academic all-American his senior year. Matt played in two-post season bowl games including the 1991 Rose Bowl.

After Matt's senior year of football, he received the prestigious Big Ten Medal of Honor given to one male and one female student athlete at each Big Tenmember institution who demonstrates a high degree of proficiency in both scholarship and athletics. Matt also received a grant from the National Directors of Athletics Association to continue his post-graduate education, in recognition of his outstanding academic and athletic success.

While at the University of Iowa, Matt excelled academically, graduating in 3 ½ years from undergraduate studies. While still a member of the football team, Matt was enrolled both in the University of Iowa Law School and the Master of Business Administration Program at the Tippie College of Business. Matt completed all of his studies—3 degrees—in 7 years, 5 of those years playing football.

Overall, the character of my legal experience is broad and diverse. I have represented government, business and individuals in both litigation and transactions. This broad and diverse experience would be a tremendous asset for me with the Court's unique position in the legal system.

The current nature of my legal experience includes: (1) criminal and civil litigation, both state and federal; and (2) business and transactional.

While I served as United States Attorney, I led 64 employees (including 26 lawyers) in three offices (Des Moines, Council Bluffs & Davenport). I was responsible for an overall operating budget of \$5.1 million. My experience included regular legal policy decisions and also included federal trials and appellate arguments. My priority as US Attorney was to serve honorably and to protect Iowans from being victims of crimes by working collaboratively with Federal, State and local law enforcement.

While at Finley Alt Smith in Des Moines, my legal experience included business and litigation matters, including insurance defense, professional liability defense, business start-up and non-profit counseling and internet and technology related counseling. For some of my tenure at Finley, I was campaigning for state-side elective office.

While at SUPERVALU, my legal experience included transactional, retail and software experience for a Fortune 100 company. I was the lead in-house attorney on major transactions including the Richfood acquisition, several multiple store acquisitions and large technology licensing contracts.

While at Briggs & Morgan and Robins Kaplan, both in Minneapolis, Minnesota, my legal experience included business and litigation representation of diverse individuals and companies. It included significant practical experience involving mergers and acquisitions, commercial contract drafting and negotiation, intellectual property counseling, litigation and dispute resolution.

Through my years of practice, each client has been unique. It would be difficult for me to describe a "typical" client. As mentioned above, I have represented the United States of America, businesses and individuals throughout

my years of practicing law and each experience and legal issue has brought me insight into the law and its application. Having served as a corporate counsel, a prosecutor and a defense lawyer will make me a strong and balanced Justice on the Iowa Supreme Court.

business and transactional than it has been in the last 9 years. I currently spend approximately 90% of my time on civil and criminal litigation matters. This balance between business and transactional practice coupled with my litigation experience gives me a broader and better understanding of business principles compared to more litigation-only applicants.

For the purposes of this Question #11, I have included only matters that have been concluded. I am currently handling some significant matters pending in both federal and state court in Iowa, including a defendant in the Iowa Film Tax Credit Office litigation and a substantial defendant in a class action anti-trust matter in the Northern District of Iowa. The below three cases demonstrate some of the broad and diverse areas of law that I have worked in during my legal career. I have not included any business related matters, for example, the \$1.5 billion Richfood acquisition that I was lead in-house counsel at SUPERVALU in 1999. I also did not include matters that I was involved in as United States Attorney but did not personally handle; for example, the CIETC investigation and the Swift and Company immigration enforcement effort in Marshalltown. I was significantly involved in these matters but did not personally handle them because I was part of a team, but each of these matters may be relevant to the Commission. Below are three significant matters that I have been lead attorney in the last several years:

# United States vs. George Ray Goff (4:07-CR-6))

I represented the United States of America as Lead Counsel and tried the case to a jury in March of 2007. Mr. Goff was charged with illegally possessing a sawed-off shotgun and being a felon in possession of a firearm, which is illegal under federal law. I was involved in the investigation in late 2006 and the indictment and trial in early 2007. Mr. Goff was convicted and sentenced to 262 months in Federal Prison. B. John Burns from the Federal Public Defender's Office represented Mr. Goff. Mr. Burns' address is 400 Locust Street, Suite 340, Des Moines, Iowa 50309. Craig Peyton Gaumer, Assistant United States Attorney served as co-counsel and handled much of the sentencing and appeal of Mr. Goff. Mr. Gaumer's address is 110 East Court Ave., Suite 200, Des Moines, Iowa 50309. The trail was conducted by Senior District Court Judge Ronald Longstaff of the Southern District of Iowa.

## **Operation Wirebreaker 2008-2009**

In 2008, I led a group of state and federal agents together with John Courter, an Assistant United States Attorney in my office, in an investigation into the sharing

of electronic images of child sexual abuse using Limewire, a peer-to-peer file sharing program. This investigation resulted in the indictment and prosecution of more than 10 individuals, some of whom were hands-on child abusers. This project demonstrates my ability to see a threat to society and lead a team to accomplish an important set of goals.

Ed Garner Autorama R.V. Center, Inc. v. Fleetwood Folding Trailers, Inc. (4-02-CV 0109)

I represented Plaintiff, Ed Garner Autorama R.V. Center, Inc. in a breach of dealership agreement and fraud trial against Fleetwood. The trial occurred in December of 2003. I was lead trial attorney, handling all aspects of the case, including summary judgment motions and deposing witnesses. The Plaintiff, Ed Garner Autorama, won the trial and the parties settled confidentially pending appeal. The trail was conducted by Thomas J. Shields, US Magistrate Judge. The Defendant was represented by Mark Zaiger, Shuttleworth & Ingersoll, 115 Third Street SE, Suite 500, Cedar Rapids, Iowa 52401.

As United States Attorney, I was named in every proceeding that involved the United States as a party in the Southern District of Iowa. This was in my official capacity. I have also been named in two private lawsuits:

Small Claims matter, Ron Ryan vs. Matt Whitaker, Iowa District Court for Johnson County-Small Claims Division. September 1992 to January 1993. Issue was regarding the return of a former roommate's portion of a security deposit after he moved out without participating in the final cleaning of the apartment. The Court awarded half of the claim, approximately \$90. That amount was subsequently paid and the judgment was satisfied.

Also, in about 2004, I was sued in the state of Nevada on a personal guarantee for a business that I was part-owner. The matter was settled privately and the case was dismissed. The amount in dispute was approximately \$10,000.

26. Why are you seeking this position?

I am seeking a position on the Iowa Supreme Court for several reasons, including, my deep experience and interest in legal policy, my significant trial experience, my standing in the legal community, my criminal defense and prosecution experience and my desire for public service.

My role as United States Attorney allowed me to be involved in legal policy decisions at the highest levels, including both the formation and implementation of policy. In so doing, I was acutely aware of not only the legal implications of my actions but also the effect that public policy has on the decision-making process. I was very involved in all aspects of legal policy. As the Chief Federal Law enforcement officer in the Southern District of Iowa, I guided the office's prosecution efforts and focus. This included which types of crimes to pursue and how to charge those crimes. Also, as chair in 2008-2009 and vice-chair in 2007-2008 of the Midwest High Intensity Drug Trafficking Area Executive Board in Kansas City, I was actively involved in regional drug enforcement matters at a policy level. I would bring this experience and interest in legal policy to the Supreme Court.

Since returning home to Iowa in 2001, I have developed my practice to include a significant portion of trial and litigation matters. I believe that I could bring this experience to the Court and make a positive impact in the Court's jurisprudence.

As a well known attorney in Iowa because of my experience both as a private practitioner and as United States Attorney, I believe that I would be well positioned to restore the Iowa Supreme Court to a position of respect and honor. I am uniquely positioned to help the Court reach out to Iowans that believe the Court has wandered beyond its constitutional authority. If selected for the Court, I would work to move the Court away from discussions of impeachment and other non-useful rhetoric from outside interest groups.

Colleagues statewide have indicated to me that the Court lacks judges with strong criminal law experience. I would bring both prosecution and defense experience to the Court and would like the opportunity to help the Court understand the balancing of interests that happens in the criminal areas of the law.

Finally, I believe that public service is an important and rewarding experience. I am seeking this position because I enjoyed my tenure in public service as United States Attorney and would enjoy another opportunity to serve the people of Iowa as a Supreme Court Justice.

# 27. How would your appointment enhance the court?

I would enhance the Court in several ways, including significant criminal law experience, a willingness to work hard, significant experience in many areas of the law and a legal philosophy that is currently not represented on the Court.

As I described above, I have both served as a prosecutor working closely with law enforcement and I have represented individuals charged with crimes. Having both of these perspectives would enhance the Iowa Supreme Court.

As you can see from my resume, I graduated from undergraduate at Iowa in three and one half years while playing on the Iowa football team. My senior season of football was my first full year of law school and I already had completed my first year of coursework toward my MBA. As recent as this fall, I was practicing law full time and also teaching a business law class for the University of Iowa in their Executive MBA program. I would bring this strong Iowa work ethic to the Court.

I have been involved in many areas of law, whether as part of my private practice, as United States Attorney, as Adjunct Assistant Professor for the University of Iowa teaching Business Law or as a small business owner. I have viewed the legal profession and the law from many perspectives and would bring this unique experience to the Court. In my Business Law class alone, I taught in areas as diverse as property law, administrative law, collective bargaining, business start-up, contracts, secured transactions and agency and employment.

I believe that the courts should not make law but faithfully interpret the law according to the Constitution, statutes and legal precedent. United States Supreme Court Chief Justice John Roberts said it best:

Judges and justices are servants of the law, not the other way around. Judges are like umpires. Umpires don't make the rules; they apply them. The role of an umpire and a judge is critical. They make sure everybody plays by the rules. But it is a limited role.

Even our founding fathers understood the proper roles of the courts when Alexander Hamilton in Federalist Paper #78 stated: "The courts must declare the sense of the law; and if they should be disposed to exercise WILL instead of JUDGMENT, the consequence would be the substitution of their pleasure for that of the legislative body" [emphasis in original].

I would bring this philosophy to the Iowa Supreme Court and thereby help restore the Court and the respect it should have in the eyes of the people of Iowa.

I have considered whether or not I should apply to the Commission for consideration to sit on Iowa's highest Court. Like many Iowans, I worry that the process is too partisan and only a certain "type" of candidate will be forwarded to the Governor.
