Valley Forge's fees for service are set forth in its filings with the SEC on Form ADV (Part II), a copy of the current version of which, as received from Valley Forge is enclosed with this Disclosure Statement. The disclosures made on Form ADV Part II are made by Valley Forge and not by VFIM. The rates disclosed in this disclosure statement or in Valley Forge's Form ADV Part II may change from time to time.
