
- Local Offenders Probation (LOP)**


In addition, the defendant shall:

3. Complete a certified **DOMESTIC VIOLENCE INTERVENTION GROUP** (additional cost will be required) or **ANGER MANAGEMENT GROUP** as determined by program regulations.
4. Undergo **SEX OFFENDER ASSESSMENT AND TREATMENT** (to include polygraph) if deemed necessary.
5. Perform _____ hours of **community service work**.
6. Pay **restitution** in the total amount of \$ _____ to _____ by making payments in the amount of \$ _____ per month. The total amount is to be paid by _____.
7. Satisfactorily pass a **criminal history record check**. (Due _____)
8. Return to Court on: June 16, 2016 @ 9:00 AM
