On September 11, 2015, at approx. 1100 hours, I responded to 3151 Regatta Blvd., Richmond, California (Blue Apron) on a report of a battery. Upon I spoke with the VICTIM and obtained the following;



I explained to VICTIM the process of making a Citizen's Arrest and VICTIM agreed. VICTIM said he would follow-up with District Attorney.

Upon contacting SUSPECT I conducted a records check on him and found he had a \$50,000.00 Ramey Arrest Warrant from Richmond Police for the crime of PC 211 (ROBBERY).
