Privacy Act Request

To Whom It May Concern:

As per the Privacy Act of 1974 (5 U.S.C. § 552a) please consider this to be a formal request for my records, as outlined below. The date range of this records request is 1980 to present.

This is a global records and files request which encompasses but is not limited to the following personal records, files and documentation, regardless of media type:

Any and all documents and data referencing or relating to interviews, investigations, complaints, suspicious activity reports, analyses, e-mails, meta data, all forms of digital communications, cables, reports, biometric data, criminal history, medical and psychological history/evaluations, information (document and file) requests from other agencies, departments, foreign governments and their respective law enforcement and security apparatus with corresponding dates and times.

This request includes any and all files, documents, records, information and data originating, gathered, received, generated or stored in Routine Databases, the Central Records System, OneDOJ, Guardian and any other bureau databases.

This request also includes any and all files, documents, records and investigations classified under the designation 190 and/or 197 main files, as well as all control files including but not limited to those with “-0,” “-2,” and “-5” designations.

This request includes all records of all designations (including 190/197) originating from or transmitted by any other agencies and kept within any of the afore-referenced databases and/or records systems.

I am also requesting any and all information generated by or relayed to the Federal Bureau of Investigation by other agencies, departments, foreign governments and their respective law enforcement and security apparatus with corresponding dates and times with specific details as to the requesting agencies/governments and reasons for the request(s).

While this is a global search request which spans the years 1980 to present, I am also specifically interested in any and all documentation, records, investigations, files and reports regarding my time in Haiti (1994 to 1995), Brazil (2001 to 2004), and Africa (Rwanda, Democratic Republic of Congo, Ethiopia, Tanzania, Kenya and Mozambique) between 2009 and 2013. Please note that the aforementioned aspect of this Privacy Act

request should not preclude the inclusion of any domestically (United States) generated documents within the same time-frame.

Records searches should principally be done under the following names and all of their variations: xxxxxxxxxx and Tristan Xango di Montenegro. In 2008 I did a legal name change in San Diego, California from xxxxxxxxxx to Tristan Xango di Montenegro and subsequently traveled with an updated passport which reflected my new name.

Since federal, state, local and foreign agencies, governments, bureaus and entities have utilized spaces and separations in different fashions for the spelling of my name, (post name-change), the following variations should also be included within this records request:

- Tristan D. Montenegro
- Tristan Di Montenegro
- Tristan Montenegro
- Tristan X. Montenegro

I am willing to pay up to \$50.00 for the processing of this request. Please inform me via writing (USPS), e-mail or phone if the estimated fees will exceed this limit before processing my request.

While my present physical address is 4390 SW 114th Court, *the FOIA response should be remitted to the mailing address contained within the header of this FOIA Request.*

If you deny all or any part of this request, please cite each specific exemption that forms the basis of your refusal to release the information and notify me of appeal procedures available under the law.

By signing this Privacy Act Request I am swearing under penalty of perjury pursuant to 28 U.S.C. 1746 that all of the above information is true.
