In fact, by denying me the requested information within 7 days of request, I can file charge of violation of the State of Indiana Sunshine law. I suggest you look up the state's Sunshine Law and Senate Bill 232: Public Access Issues.

As far as the Federal Government, They claim that your officer performed the Search Warrant and for which he, your officer removed my property from the place it was secured. The FBI claimed that they were called later. The FBI stated, that all property removed in said Search Warrant was in the care of the Bedford City Police Property Unit. There is no active investigation at this time in regard to my property that was taken.

Take note, the Federal Government has complied fully with my similar request in a timely manner and without any resistance.

If I do not receive this information in a timely manner as required by law, I will seek to enforce the State Law and all its fines, even if I have to go to the Federal Level to do it.

If there is no response, action will be made within 8 days after receipt of this letter to enforce all state laws, not excluding fines imposed for such violation.
