If you deny all or part of this request, please cite the specific exemption(s) you believe justify your refusal to release the information or permit the review of the information, describe how disclosure would harm the interests claimed by the exemption, and notify us of your appeal procedures available under the law. Pursuant to FOIA, if the SBA believes that a portion of information in a record cannot be released, we request that the SBA produce all reasonably segregable, non-exempt portions of the record.

FOIA requires the SBA to respond to this request within 20 working days. Thus, we expect the SBA to provide the response within that timeframe.
