TA distributed list of potential questions for police chief interviews provided to her by each of the selectmen, which she will collate and organize for further review by BoS.

Selectmen deliberated about contract negotiations with Warren Ryder, who had been selected by the Board as the new Police Chief. The Board discussed offering an initial term of 15 months; extension of contract to be contingent upon a satisfactory performance review; also discussed vehicle and uniform allowance. Selectmen agreed that the new Chief should meet with the BoS on May 3 to discuss goals. BoS then discussed salary and noted that Sergeant Ryder was currently earning a base of \$60,698, \$72,829 with Quinn and not including overtime. Member Fox moved to begin negotiations at \$88,000 and not to exceed \$95,000. Seconded by Member Suleiman. **Approved 4 - 0** by roll call vote: Powers "aye" Neville "aye," Suleiman "aye" and Fox "aye." It was agreed that Chair Neville and Member Powers would meet to negotiate with Warren on March 30, with the hope of appointing him that evening.

Chair Neville convened executive session at 9:05 PM in the Town Administrator's office, Town Hall to discuss strategy with respect to negotiations with non-union personnel (Fire Chief).

Member Suleiman reported on meeting with Chief Neagle and Selectman Fox to review salary surveys. Chief had presented survey provided by Littleton's Chief Carter and contended that town's figures were inaccurate. Selectmen reviewed the data on both surveys and noted that Carter survey was out-dated, provided data for towns deemed not comparable and was inflated with holiday pay, which was inaccurately shown as an addition to base salary. Selectmen reiterated their opinion that Chief's salary is in-line with comparable communities, and agreed that a 1% increase was reasonable and generally consistent with other non-union FY 11 increases. Selectmen agreed that the towns of Ayer, Stow, Harvard, Littleton, Maynard and Shirley should be highlighted on town's survey, which will be discussed again by Member Suleiman with the Chief.

At 9:50 PM, Member Suleiman moved to adjourn; seconded by Member Powers. **Approved 3 - 0** by roll call vote: Suleiman "aye," Powers "aye" and Neville "aye."

Chair Neville opened the meeting at 7:37 PM in the Morse/Hilberg room, Town Hall, to discuss strategy with respect to negotiations with non-union personnel.

The Board first addressed a request from the Police Chief to work details provided all Boxborough police officers had turned down a detail request. The Board agreed that the Chief should be able to work details under those conditions.

Member Suleiman reported on his email and phone discussion with the Fire Chief concerning the potential amount of his salary increase. Chief Neagle was reportedly unhappy with the initial amount (between 1 and 1.5%) that the Board was offering. There was discussion about the salary survey data which was used by the Selectmen and an alternative set of figures proposed by Chief Neagle. After discussion, the Board agreed that the salary data prepared by the Town Administrator was the appropriate data to use. The Board also opined that offering a salary increase greater than 1% would be unfair to other town personnel whose salaries had increased by 1%.

Following deliberation, Chair Neville moved to offer Chief Neagle a salary increase of 1%, contingent on a satisfactory performance evaluation. Seconded by Member Powers, **approved 4-0** by roll-call vote (Neville "aye", Powers "aye", Fox "aye"; Suleiman "aye").

Member Fox reported on meeting with Chief Neagle and Selectman Suleiman to negotiate salary. Chief had requested salary increase of 4%. Chair Neville reiterated that 1% was the maximum that she would consider. Member Suleiman commented that he could agree to a max of 2%. Concern expressed about opening "Pandora's box"... Member Powers reiterated that the survey put the Chief at the right level. Chair Powers convened executive session at 8:50 PM in the Town Administrator's office, Town Hall to discuss strategy with respect to negotiations with non-union personnel (Fire Chief).

Member Suleiman reported on meeting with Fire Chief Neagle and Selectman Fox to negotiate salary. Chief agreed to 1% increase in first year and asked that the BoS agree to conduct an updated salary survey for the second year of the agreement. Member Fox reported that the tenor of the discussions was good. Selectmen discussed proposed terms of agreement: salary of \$88,267.21, reflecting a 1% increase in first year; term expiring June 5, 2012 (65th birthday, consistent with stipulations in the general laws); a possible salary increase in 2nd year to be negotiated upon review of an updated salary survey and contingent upon an overall performance rating of at least "meets requirements" and the requirement that a time card be submitted for each pay period (consistent with contract of Police Chief and to be incorporated into side letters for DPW Director and TA). Member Fox moved that the Board authorize the Fire Department liaison to present a new contract to Chief Neagle reflecting a 1% salary increase in the first year with other changes and revisions as noted. Seconded by Member Neville. **Approved 5 - 0** by roll call vote: Neville "aye," Suleiman "aye," Powers "aye," Fox "aye" and Robinson "aye." Member Suleiman also commented that he would request Chief to submit his goals prior to June 1.

Member Suleiman moved to execute the agreement with Chief Neagle as written for the term July 1, 2010 – June 30, 2012 (with no change in time card provision from prior year's agreement). The Chair explained that the union seems to understand that the grievance must be denied; however they were seeking to open a dialogue on the matter of Quinn in general. The selectmen discussed the matter and agreed that they did not want to do anything to prejudice the upcoming arbitration on September 15, that they would hear on the grievance and listen. Further, it was agreed that TA and Chair Powers would discuss the strategy on the matter with Town Counsel.

TA provided an update on a communication that had been received by the Assessor and herself from Attorney Kenneth W. Gurge in the matter of 80 Central Street. TA and Selectmen discussed the practice of representatives filing abatements on behalf of property owner, the implications and the Assessor's strategy moving forward.

Chair Powers convened the Board of Selectmen's meeting at 7:02 PM in the Town Administrator's office, Town Hall. Member Neville then moved to adjourn to executive session to discuss strategy with respect to collective bargaining [MassCOPs] because an open meeting might have a detrimental effect on the bargaining position of the town, and to adjourn immediately thereafter without returning to open session. The motion was seconded by Member Suleiman and **approved 5 - 0** by a roll call vote: Neville "aye," Fox "aye," Suleiman "aye," Powers "aye" and Robinson "aye."

Chair Powers summarized the telephone discussion that had taken place with Town Counsel and the Town Administrator regarding the Quinn grievances. Town Counsel Joe Fair reviewed the matters with the Board and discussed the status of Quinn cases in the state as well as the approach to the issue taken by other communities across the Commonwealth. Attorney Fair reviewed available options with the Board:

- 1) go forward with arbitration,
- 2) agree to postpone the arbitration, or
- 3) hold the matter in abeyance (for a maximum of 6 months).

Member Neville moved that the Board of Selectmen seek agreement from the union to hold both matters in abeyance and attempt to negotiate. Seconded by Member Suleiman and **approved 5 - 0** by a roll call vote: Neville "aye," Suleiman "aye," Fox "aye," Powers "aye" and Robinson "aye."

Shortly after 7:30PM, Member Suleiman excused himself. The Board continued to discuss the strategy moving forward and the plan of action for Monday's meeting with the union. Counsel advised that the outcome of Monday's hearing should be memorialized in writing, by a confirming letter of understanding to the union and the Board should so vote on Monday evening.

Adjourning immediately after having called the Board of Selectmen's meeting to order in open session, Chair Powers convened executive session at 7:00 PM in the Town Administrator's office, Town Hall to discuss strategy with respect to collective bargaining [MassCOPs] as well as to conduct a collective bargaining session (hold a grievance hearing with respect to the matter of Officer Gath and Quinn).

Officer Brett Pelley, representing the collective bargaining unit (CBU), reviewed the reasons for having filed the grievance on behalf of Officer Gath and the CBU. Officer Pelley stated that Officer Gath had not received any career incentive pay as the CBU believed that he should based upon its understanding of what had been negotiated in the collective bargaining agreement (CBA). The CBU believes that Quinn and education incentive are "two different animals" and that Officer Gath should have been compensated 12.5% per Article 12 §5 for having attained a Masters Degree. Officer Pelley also stated that filing the grievance was the only way the CBU thought that they could open a dialog with the BoS on the matter of Quinn. After Officer Pelley had completed his comments, Chair Powers asked him to step outside so the BoS could deliberate on the matter.

After Chair Powers reviewed with Chief Ryder the proposed strategy that had been voted upon by the Board on 19th August, Officer Pelley was invited to return. Chair Powers proposed that the BoS and CBU agree to:

- 1) Postpone any specific decision related to the "Gath grievance" and hold the matter in abeyance
- 2) Hold the grievance which had been scheduled for arbitration on 15th September in abeyance for a period not to exceed six months
- 3) During the abeyance period, attempt to negotiate a mutually acceptable resolution in the above-referenced matters

Officer Pelley was very pleased with the proposal and agreed to take it back to the CBU for a vote and to confirm the outcome with the BoS Chair and Town Administrator, hopefully by Wednesday.

Member Fox moved that the Board of Selectmen authorize the Town Administrator to send a confirming letter of understanding to the CBU on the proposal set forth by the BoS. Seconded by Member Suleiman and **approved 4 - 0** by a roll call vote: Fox "aye," Suleiman "aye," Powers "aye" and Robinson "aye."

At 7:18 PM, Member Suleiman moved to adjourn from executive session and to recess until 7:30 PM, when the Board would reconvene in open session in the Grange Meeting Room. Seconded by Member Fox. **Approved 4 - 0** by roll call vote: Fox "aye," Suleiman "aye," Powers "aye" and Robinson "aye."

After union members departed, there was additional brief discussion on strategy. Team also set another meeting, without the union, on October 12 (3:40 PM).
