If part of the requested information becomes available immediately, I would prefer to have immediate access to that material rather than wait while the remainder of the information is being prepared for review.

Because this case involves significant issues of importance to the people of Wisconsin concerning the actions of our top political leaders including Gov. Scott Walker, the Wisconsin Freedom of Information Council respectfully asks that all fees for this request, which is being made on behalf of the public, be waived, as allowed under the law. If you choose to charge a fee for these court records – which normally under the law are presumed to be open for public inspection – the law states that you may charge reasonable fees for making copies. If all or part of this request is denied, please cite the specific law or regulation for the denial and inform me of the appeal procedures. I believe that the records I am seeking are public records and thus should be available for inspection and copying during your regular office hours.

Please handle this request expeditiously so that I may pursue legal remedies, if necessary, to gain access to the information I am seeking. If I can clarify or refine this request, please let me know.
