At approxiamtley 0106 hours Tulsa Police responded to a second shooting at 1390 E. 51<sup>st</sup> Place North, City of Tulsa Tulsa County. Upon Officers arrival they discovered two victims of a shooting. The victims were ransported to a local hospital where they were treated for gunshot wounds. One of the victims stated to officers that they were shot by a white male in a white truck. They further described that the truck had loud exhaust.

Later at approximately 0150 hours, TPD officers responded to a man down call at 310 W. 63<sup>rd</sup> Street North, City of Tulsa, Tulsa County. At the time the victim was treated by EMSA and transported to the hospital. While en route to the hospital the victim died. While at the hospital doctors discovered that the victim had a gunshot wound to his upper torso.

At approximately 0812 hours TPD officers responded to call of a man down at 801 E. 36<sup>th</sup> Street North. The first officer that arrived discovered that the subject was deceased. Upon further examination it was discovered that the subject suffered a gunshot to the chest area.

On 040612 detectives conducted their investigation into the shootings of the above listed victims. Canvas of the neighborhood revealed that witnesses observed a white Chevy truck with a loud exhaust in two of the our shootings.

On 040712 Officers received several Crime Stoppers tip naming the suspect of the shootings as Jake England. Officers then attempted to locate information on Jake England. The tips further stated that England was in possession of the white truck and that he was making plans on burning the vehicle. At approximately 1800 hours Osage County Deputies located a vehicle burned at 6000 N. Osage Drive. The tag on the vehicle checked to Carl or Jacob England at 2800 E 61<sup>st</sup> Street North.

Further a search warrant and arrest warrant were obtained for Jacob England and his residence. Through surveillance and the ongoing investigation, Jacob England was located at 6210 North Yorktown.

England was transported to the Detective Division where he was Mirandized. The listed subject agreed to speak to Detectives and during the course of the interview he confessed to being the driver of the vehicle while Watts shot two of victims. He also stated the he shot three victims. He also gave detectives the location of the gun used in the shootings.

Watts was booked into DLM for the three murders and two SWIK's.

Based on Watts description of the events the two individual that he stated he shot are two of the three victims that died.

Watts was booked into DLM for the three murders and two SWIK's.
