
I represent Mr. Ed Lopez and the Assassination Archives and Research Center ("AARC"). A privacy waiver executed by Mr. Lopez is attached hereto. Pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, the Privacy Act, 5 U.S.C. § 552a. and the President John F. Kennedy Assassination Records Collection Act of 1992 ("JFK Records Act"), 5 U.S.C. § 552 note, I hereby request completely unredacted copies of the following records:

1. The 40-page document which is described by RIF #104-10175-10085 (hereafter referred to as "the Ed Lopez file.").
2. Any record reflecting a vote by the Assassination Records Review Board (ARRB) to designating the Lopez file as "NBR" ("Not Believed Relevant") or similar status or determining that its disclosure should be withheld for a particular period of time, including until 2017.
3. Any record of the CIA or any other agency reflecting the belief that the Lopez file should or might be given "NBR" status or that its disclosure should be postponed for any period of time, including until the year 2017.
4. Any record reflecting that the disclosure of the Lopez file should be postponed in whole or in part for any period of time, including until 2017, was
