REASONS FOR DECISION(S)

The Board has received a recommendation from the Correctional Service of Canada to remove the special condition requiring you to reside at a specific place. In relation to this request, the Board has considered the following:

You are serving a seven year sentence for Perjury. You committed this offence when called to testify against your co-accused from your manslaughter conviction. You were found to have made false statements with intent to mislead the Court. File information indicates that as a result of your committing perjury, the co-accused were not convicted of any criminal offences.

Your criminal history includes prior convictions for Manslaughter (x3) Possession of Unregistered Restricted Weapon and Unlawful Possession of Explosives, Make Explosive Substance with Intent to Cause an Explosion, Unlawfully Acquiring Explosive Substance with Intent to Cause an Explosion, Make Explosive Substance and Possession of Explosive Substance.

All of your convictions are connected to your involvement in the deaths of 331 people in terrorist attacks.

In January 2016, the Board imposed a condition requiring you to reside at a specific place. In Imposing the condition, the Board noted that you were involved in terrorist activity that took the lives of 331 people, you made false statements to purposely misled the court and there was limited information as to whether you had fully disassociated from the extremist individuals you were involved with.

Your case management team (CMT) reports that since your release to the community, you have been abiding by all the conditions of your release. There has been no evidence of communication with any negative associates who may hold extremist views or be involved in political activity. There have been no police concerns since your release, and the High Risk Target Team is supportive of the removal of your residency condition. You have been participating in ongoing

psychological counselling to address cognitive distortions and violent behaviour. You have been described as highly accountable for your activities and your whereabouts. There is no evidence that you continue to associate with your co-accused and you have indicated that you have no desire to establish contact. You now express strong views against violence. You spend time at your family home, and you are described as diligent about reporting your associates to your CMT.

According to psychological assessments your risk to re-offend is low, however if there were a threat to your Sikh cause, your risk for future based group violence is high. There is no information that indicates your political cause is under threat. Your CMT has indicated that a number of measures will be put in place in order to adequately monitor your risk, should the residency condition be removed.

The Board notes that your criminal behaviour contributed to the deaths of 331 people. Your alliance to your associates was strong enough that you were willing to lie for them in court. There were concerns about your continued affiliation while you were incarcerated. However, it appears that while you have been managing your release well and you have abided by your imposed conditions. You appear to have disassociated yourself from individuals you offended with and you are described as accountable for your activities and whereabouts. Your CMT indicates that a residency condition is no longer necessary to manage your risk to the community. You are participating actively in counselling to continue to address your risk for violence. As it appears you no longer require the support and supervision of a CRF, and there is an adequate alternate plan to manage your risk in the community, the Board concludes your risk would not elevate to an undue level should the residency condition be removed. Therefore, the Board removes the condition to reside at a specific place. All other previously imposed conditions remain in effect.
