	There is a large number of Morning Clips. I had to run 3 separate but simi searches in Gmail to fulfill the request. The 1st search search returned 116 emails and approximately 1033 are clips. The other two searches probably have the same type of results. So maybe 300 valid emails is my guess.

	Thanks for your response. A few answers to your comments and questions:

copying unless the content of certain records are considered

confidential as provided by law. As such, all 3,500 or so emails estimated by the technology office in connection with this request must be reviewed for potentially protected information before they can be released.

As to your question about citing exemptions to Iowa's open records law, our office cites the exemptions we rely upon in our responses, should any exemptions apply.

As to your inquiry about our non-binding estimates, because we do not know how long it may actually take to review and produce potentially responsive records in advance, we can only give a nonbinding prediction for how long a particular request will take and how must a particular request may cost. All requests are processed as quickly as possible and in accordance with Iowa law. Our office will only charge you for the actual time and effort it takes to fulfill a particular request.

As to your request for copies of invitations to those that were invited to the bill signing you reference, we will provide that information to you in accordance with Iowa law.

Please let our office know how you would like us to proceed.


Thank you for the information and the estimate. I am somewhat surprised by the cost, however. Given the IT staff clearly can run electronic queries and electronically provide the information on a thumb drive, which I am happy to provide if needed, the cost is estimated at \$1441 seems a bit high to me having worked in the IT arena for over a decade. I was not asking for a review of the e-mails just simply for the information to be downloaded which should not take more than a couple of hours from my previous experience.

So, now I have more questions that I hope you can help me to understand.

As I understand Chapter 22, commonly known as the lowa public records law, it makes all documents, including correspondence and emails, available to the public unless there is a specific exception to this presumption of openness that is enumerated in Chapter 22. So, if your review is intended to restrict some documents, if you believe any of the documents I am requesting cannot be released, would you please cite the specific exception on which you base that belief?

Additionally, can you explain to me what "non-binding" estimate means?

Also, can you please send me the list of those invited to the bill signing as soon as possible? Thank you.

Thank you for your response. The listing of information requested is correct. I would prefer to have the documents in electronic form rather than hard copies. Please give me an estimate of the time and expense

likely to be involved so that I can either confirm or narrow the listing.
As to the request related to those attending the bill signing for the collective bargaining reform legislation on February 17, 2017, I find it hard to believe that such a list does not exist or cannot be recreated. Both you and I know that individuals just don't walk into the Governor's office to attend a bill signing; they are invited to attend. So, someone on the Governor's staff must have invited individuals to attend (or must have directed lobbyists or others involved in the bill's passage to invite individuals to attend). That is the information I am seeking. I expect that the information can in fact be obtained with some diligence on your part.
I'll look forward to receipt of the estimate of time and dollars involved in complying with my information request.
