If for any reason fees do become an issue, we will address your fee waiver request at that time.

> We are granting your request for expedited processing, in accordance with Department of Defense (DoD) Regulation 5400.7-R, and have initiated the necessary search actions with the appropriate components of the Office of the Secretary of Defense (OSD).

> For your awareness, please understand that the granting of expedited processing does not provide for a guarantee that your request will be completed by a certain date, as all of our required procedures for searching and reviewing any records located, must be followed. In fact, although the FOIA requires agencies to respond to FOIA requests within 20-working days after receipt of a valid request, due to "unusual circumstances" we will not be able to make a release determination within this 20-day timeframe. The unusual circumstances which preclude us from meeting this deadline include the following: (a) the need to search for and collect records from a facility geographically separated from this Office; (b) the potential volume of records responsive to your request; and (c) the need for consultation with one or more other agencies or DoD components having a substantial interest in either the determination or the subject matter of the records. These circumstances impact the total time required to process your request to completion. So, again, placing your request at the top of the FOIA queue simply means that the work of processing your request is underway.
