## Official footprint in Russian Federation

- 3.1 We understand that Scott Young has a very limited footprint in Russia. He does not have a media profile in Russia and has never been in the possession of short or long term residence permits.
- 3.2 Furthermore, he has never been registered with the Russian Police Force as all visiting residents / long-term visitors are required to be.
- 3.3 Scott Young is not known to have rented any residential properties in Russia or lived in a property rented by someone else.
- 3.4 Retrieved customs records suggest that Scott Young has only made short business trips to Russia, and only once held a multi-entry visa.
- 3.5 We understand that during his visits Scott Young has stayed at three Moscow hotels; Marriot Grand, Hyatt Grand Ararat and Hotel National. All three hotels confirmed they have records of his stay, but none said they recognise Scott Young as a regular customer;

# **Local Interest in Scott Young**

- 3.10 We have been informed that Scott Young never carried cash or shares and never paid anyone inside Russia or transferred documents of a sensitive commercial nature to local businessmen. Our investigation showed that actual deals would be executed in Monaco, in a restaurant attached to the Casino Café du Paris. Scott Young frequently had restaurant bills from this casino and he would schedule meetings there with Russian contacts using his Russian mobile phones.
- 3.11 Scott Young is said never to have met Berezovsky / Patarkatsishvili, or

  (another oligarch connected with ORT that Scott Young is said to have worked for) inside Russia. All meetings in Moscow related to his business with the above oligarchs happened between 2001 and 2003 and were held with either

3.13 Our sources inform us that Scott Young spent most of his time in Moscow enjoying himself. His typical night out would be a long drink/dinner at Café Pushkin, Vogue Café, Restaurant Vanille and then a visit to Private Club Bordo, a high-class brothel in Moscow.

# Personal assets in Russia

- 3.14 Initial enquiries indicate Scott Young has no liquid assets registered in his own name in Russia.
- 3.15 As per records maintained by the Centralised Archive of the State Registration Chamber of the Ministry of Justice he does not own residential property in Russia
- 3.16 Nor is he known to own commercial or private-use land, as per records maintained by the State Land Registry Federal Agency

# Associations with Berezovsky

- 3.22 We have been able to discretely discuss the subject matter with is known to have worked on behalf of Berezovsky for over three years.

  had led some real estate projects for Berezovsky. His comments were as follows:
  - (i) Berezovsky is a very bad payer so Scott Young may have easily found himself in a situation where he'd sell a property to Berezovsky but would not get paid the full amount in return. We understand that Berezovsky owes several million GBP to Scott Young but Scott Young has not gone public for security and reputational concerns.
  - (ii) Scott Young once sold a property registered to his own firm to a third party on behalf of Berezovsky then wired all the proceeds minus a fairly small commission (GBP 75,000) back to Berezovsky but has never been reimbursed by Beresovsky for the tax bill in respect to that particular property. We understand that this typical behaviour for Berezovsky and he has probably done this many times to many fixers.
