**Narrative**

On 06/06/2017 at approximately 14:19 hours I was at South Burlington High School where I serve as a School Resource Officer. I was contacted by school employee and [REDACTED] ① [REDACTED], [REDACTED] who advised me he had located a racial slur written on the turf.

I went out to the field and met with [REDACTED] ① where he directed me to approximately the 40 yard line of the field. Written in white spray paint was [REDACTED] the ② writing was in all capitals and stretched the majority of the width of the field. I photographed the writing from the field level, and from the top of the bleachers where it was visible.

I contacted acting principal Patrick Phillips (01/10/1956) and advised him of the situation. Superintendent David Young was also notified.

I additionally contacted LT. Jeff Martel of SBPD to notify him of the situation.

SBSD buildings and grounds crew was contacted and responded to the field, covering up the writing with a tarp and began to work on removal of the graffiti. They were able to remove several of the words, and secured the tarp with sand bags covering the remaining words until it could be dealt with the next day.

Additionally, the SBHS boys lacrosse team was scheduled to have a playoff game on the turf at 16:30 hours, against the Burr and Burton boys lacrosse team which had arrived at the school a short time after the vandalism was discovered. The game was rescheduled for 17:00 hours at Burlington High School.

It was believed that ██████████ ① was the first person to locate the vandalism. It had been raining heavily all day, and none of the gym classes or middle school recesses were held outside. Additionally, it appeared the spray paint had been applied before the rain had started. This led me to believe the vandalism had been done overnight.

Per school district policy I made a surveillance video request to view footage from the school parking lots beginning on 06/05/2017 at approximately 18:00 hours until approximately 06:00 hours on 06/06/2017. I made the request to SBSD Superintendent David Young, and SBPD Police Chief Trevor Whipple. The video request was approved by both.

On the morning of 06/07/2017 I met with District IT staff member Andy Pearson. Pearson accessed the surveillance footage and located footage of the following.

On 06/05/2017 at approximately 23:26 hours a vehicle entered the parking lot in between the South Burlington High School and Middle School and entered into the bus lane in front of the turf field. The vehicle parked near the entrance to the turf field, and at least 1 individual wearing a light colored shirt exited the vehicle.

At approximately 23:55 hours the vehicle exited and drove out of the bus lane, past the front of the middle school and left school grounds.

Surveillance footage was obtained from a camera on the corner of the South Burlington High School building closest to the field which captured footage of the vehicle entering, and from the front of Fredrick H. Tuttle Middle School which captured footage of the vehicle exiting. Pearson was able to provide me with several still photos of the vehicle.

The footage of the vehicle is not very high quality, however, it appeared to be a light colored 4 door vehicle with a sun roof.

Still photos of the surveillance footage, and pictures of the vandalism on the field are attached to this case.

As of 13:00 hours on 06/07/2017 SBSB buildings and grounds crew were still working to remove the graffiti from the turf field. Additionally, the company SERVPRO was brought in to assist with the removal. The turf is a brand new surface which was installed in the summer of 2016.
