Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it: As a result of an internal investigation, a review of Trooper Richardson's patrol activity was initiated. During that review, I interviewed Town Gomes, a female driver who was stopped by Trooper Richardson in August of 2016. Ms. G that Trooper Richardson stopped her for speeding and driving on a suspended license and that Trooper Richardson had her car towed. Trooper Richardson drove to a nearby Wawa to drop her off and after exiting the patrol car, Trooper Richardson asked her out on a date. Ms. General further indicated that Trooper Richardson stopped her again on December of 2016. During that stop, Trooper Richardson again attempted to pursue a relationship with her and threatened to have her arrested if she did not give him her phone number. Ms. G had a warrant from Collingswood Municipal Court at the time. After Trooper Richardson obtained Ms. G. 's number, Ms. asked him how he explained the stop to dispatch. Trooper Richardson indicated that he told dispatch it was a male driver. A review of the CAD abstract and DIVR footage confirms that Trooper Richardson stopped Ms. General's vehicle on December 23, 2016. After retrieving documents from the driver, Trooper Richardson returned to his troop car and advised dispatch that he had stopped a black male with a DOB of 4/12/1988. The CAD abstract does not include the driver's name, address, or driver's license number. At that point, the DIVR was deactivated. These facts, in conjunction with other documents, records, and statements obtained during the course of the investigation, show that the defendant knowingly made a false entry in, or false alteration of, any record, document or thing belonging to, or received or kept by, the government for information or record, or required by law to be kept by others for information or the government.
