

A formal engagement has not yet been finalized; the registrant has agreed to perform the Services under the following terms: standard hourly rates that currently range from approximately \$400 to \$850 per hour; the term of the engagement for the Services is estimated to be one year.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

As requested by the foreign principal, registrant renders advice on matters involving the foreign principal's activities and exchanges with the United States government, including FinCEN and other United States officials and agencies. 
