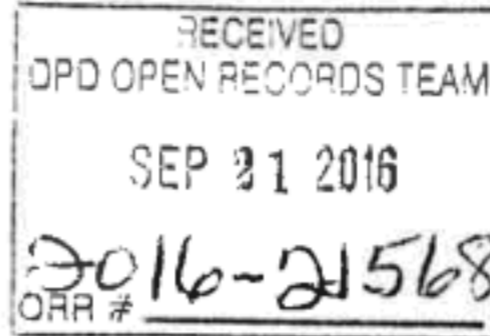

Narrative Information

On August 10, 2016, the Complainant was involved in a disturbance and was contacted by witnesses. Complainant was handcuffed for his safety until Dallas Police Officers arrived. Complainant was exhibiting erratic behavior that included aggressive and combative in nature. DFR was called to the location after the complainant began to exhibit medical distress. Complainant was transported to Parkland where he died from unknown causes. The complainant was pronounced deceased by Dr. Cohen at 11:30pm. The complainant will be transported to the Dallas County Medical Examiners Office for autopsy.
