Narrative

FCM [REDACTED] contacted Ms. Taylor in regards to the report of physical abuse on her seven month old son, Jayden. Ms. Taylor reported she is currently out of town in Dayton, Ohio, and will not return until late Monday night. FCM Walker asked Ms. Taylor where was the child, and she reported in Shelbyville, IN, with her mother. Ms. Taylor provided FCM with maternal grandmother's name, number, and address. Ms. Taylor reported that Jayden's father is going back and forth with her because he is not happy that she has a new boyfriend. Ms. Taylor proceeded to inform FCM that her boyfriend has a 19 month old daughter, [REDACTED], who has overnight visits with the boyfriend. The child, Jayden, was in the pack and play when the 19 month old, [REDACTED], threw a toy into the pack and play and it hit Jayden in the face. Ms. Taylor reported the side of his face and ear was bruised so she took him to ER at Major Hospital in Shelbyville, Indiana and Jayden was medically cleared. Ms. Taylor scheduled an appointment with FCM [REDACTED] on Tuesday, August 9, 2011, at 10:00am in her home. FCM [REDACTED] informed Ms. Taylor that the child, Jayden needs to be present during the visit. Ms. Taylor agreed.

Narrative

FCM [REDACTED] met with Ms. Taylor face to face in her home. FCM [REDACTED] went over the allegations with Ms. Taylor. Ms. Taylor apologized to FCM Walker for giving a false story on 08/05/11, in regards to the child's injuries. Ms. Taylor reported that alot was going on at that time, they were out of town and did not want people to know what was going on. Ms. Taylor reported that she got a protected order served on Jayden's father and he became upset and have been causing problems. Ms. Taylor reported that the father, resides in Shelbyville, so whenever she goes to visit her mother or take Jayden to her mom's she meets the father somewhere so he can see Jayden. Ms. Taylor reported that her boyfriend (Ryan Worlin) had awoken with the children around 5:00am. Ms. Taylor reported that Ryan had placed Jayden into the pack and play on his back, and placed a toy into the pack and play. Jayden rolled over twice in the pack and play and the side of his face and ear hit the toy. Ms. Taylor reported she was asleep in the bedroom and Ryan immediately woke her up. Ms. Taylor reported that Jayden cried for 30 seconds. Ms. Taylor reported his face was red. Ms. Taylor reported around 8 or 9am, the bruises came onto Jayden's face, she called her mom, and left and went to her parents' home. Ms. Taylor reported that she and her mother transported Jayden to Major Hospital and he was medically cleared.

Ms. Taylor reported the next day she took the child, Jayden, to see his father the next day and explained to him that it was an accident. Ms. Taylor reported that at the time, the father had no concerns about it. Ms. Taylor reported three days later he started accusing Ms. Taylor's boyfriend of grabbing the child by the face and kept telling people that Ms. Taylor told him that her boyfriend grabbed the child by his face. Ms. Taylor reported he was upset because they were not getting back together and she took a order of protection out on him. FCM had Ms. Taylor sign FSCS plans, and NOA. FCM Walker observed the home to be appropriate and no safety concerns.

**Narrative**

On August 5, 2011, The Marion County Department of Child Services received a physical abuse report. The 310 states that Chelsea Taylor is the mother of 7 month old Jayden Noel. The child, Jayden, had bruises on the right side of his face, lip was cut, and ear was black. The allegations are against the mother's boyfriend, Ryan Worlin. The 310 states that the mother, Chelsea Taylor was present during the injuries.

FCM ██████ assigned the case on 08/05/11.

Chelsea Taylor does not have any prior CPS history.

On 08/05/11, FCM ██████ spoke with Ms. Taylor in regards to the allegations. Ms. Taylor reported she was in Ohio with her boyfriend, and will not return until late Monday night. Ms. Taylor reported that the child, Jayden, was with maternal grandmother in Shelbyville, IN. Ms. Taylor scheduled an appointment with FCM ██████ for August 9, 2011, at 10:00am. Ms. Taylor then reported to FCM ██████ that the child's father is upset with her and called in the report. Ms. Taylor reported that the child was in the pack and play, when her boyfriend's daughter, ██████ (19 months), threw a toy into the pack and play and the toy hit the child, Jayden in the head. FCM ██████ then told Ms. Taylor that they will discuss allegations on August 9, 2011, in her home at 10:00am.

On 08/09/11, FCM ██████ met with the mother, Chelsea Taylor in her home. Ms. Taylor reported to FCM ██████ that her boyfriend, Ryan Worlin, woke up with the children around 5:00am. Ms. Taylor reported that Ryan put the child, Jayden, into the pack and play. The boyfriend put a toy into the pack and play and Jayden flipped over twice onto the two on his left side which caused bruising on his face and ear. Ms. Taylor reported that Ryan immediately awakens her and she noticed the redness, but no marks or bruises. Ms. Taylor reported around 8am, she noticed the child had bruises on his face. Ms. Taylor reported she left to go her mother's home in Shelbyville, Indiana, around 10:00am. The maternal grandmother, ██████, and ██████, transported the child to the emergency room at Major Hospital in Shelbyville, Indiana. Ms. ██████ reported that the doctors examined Jayden, and he was medically cleared and she was instructed to follow up with his pediatrician if any other problems occur.

08/09/11, FCM ██████ met face to face with the child, Jayden in his home. Jayden appeared to be happy today. Jayden was dressed appropriately. Jayden appears to be developing age appropriately. FCM Walker did not observe any bruises, marks, or welts on Jayden. FCM ██████ observed a baby bed, pack and play, formula, baby food, and car seat for the child Jayden. The home was appropriate. All utilities were on, and there were no safety concerns.

On 08/12/11, FCM ██████ attempted to contact the reporting source and was unsuccessful. FCM ██████ left a message for report source to return her call.

On 08/15/11, FCM ██████ attempted to contact the father, Jerraco Noel, in regards to the report. FCM ██████ was unsuccessful and left her name and number for Mr. Noel to contact FCM ██████ as soon as possible.

On 08/19/11, FCM ██████ met face to face with the boyfriend, Ryan Worlin, in the home. Mr. Worlin reported to FCM ██████ that his daughter, ██████ (19 months), was over to the home for an overnight visit. The children had awakened around 5:00am and he decided to get up with the children so the mother, Ms. Taylor could sleep. Mr. Worlin reported he did not turn on any lights, grabbed the pack and play and placed the child, Jayden into the pack and play. Mr. Worlin reported he picked up a toy and dropped it into the pack and plays, heard a thump, and the child Jayden began to cry. Mr. Worlin then noticed he dropped the toy onto the child, Jayden. Mr. Worlin immediately woke up Ms. Taylor. Mr. Worlin reported he is left alone with the child, Jayden once or twice a week while Ms. Taylor runs to the store.

On 08/19/11, FCM ██████ spoke with the father, Jerraco Noel, who agreed to come into the DCS office on August 23, 2011, at 11:00am, to speak with FCM ██████ about the report.

On 08/23/11, Mr. Noel did not show up into the DCS office for the appointment. FCM ██████ attempted to call Mr. Noel in regards to the appointment that was scheduled for 11:00am and was unsuccessful. FCM ██████ left Mr. Noel a message to return her call.

Between 08/24/11 and 08/29/11, FCM ██████ has attempted to contact the report source via telephone and was unsuccessful. FCM Walker left messages for the report source to return her call as soon as possible.

On 08/29/11, FCM ██████ spoke with the maternal grandmother, ██████. Ms. ██████ reported to FCM ██████ that she received a phone call around 10:00am from her daughter, Chelsea Taylor, stating the child was hit with a toy. Ms. ██████ reported that her daughter, Chelsea, reported that the child had a busted lip and his nose was bleeding. Chelsea explained to Ms. ██████ that Ryan had gotten up with the children and threw a toy into the pack and play hitting the child, Jayden. Ms. ██████ reported that Chelsea explained to her that she applied ice to the injuries and the swelling went down. Ms. ██████ reported that Chelsea and the child, Jayden went back to sleep and had awoken 3 hours later and Chelsea noticed more bruising and called Ms. ██████ back. Ms. ██████ reported she then explained to Chelsea to bring the child down to her home and they would transport to ER. Ms. ██████ reported the child was cleared from the ER and the doctor. Chelsea was instructed to bring the child back if the child begins to show signs of loss of consciousness. Ms. ██████ reported she keeps her grandson every Tuesday, 16 hours on Saturdays and 6 hours on Sunday. Ms. ██████ reported she checks Jayden for bruises or marks every time he comes to visit. Ms. Taylor reported this is the first time anything has happened to Jayden and believes it was an accident.

On 08/29/11 and 08/30/11, FCM ██████ attempted to reach the father, Jerraco Noel, via telephone and was unsuccessful. FCM ██████ left messages for Mr. Noel to return her call.

After interviewing all parties there is a lack of preponderance of evidence to support that the allegations of physical abuse is true. Chelsea Taylor and Ryan Worlin reported the incident was an accident and Ms. ██████ ensured the child received proper medical attention. Therefore, abuse is unsubstantiated. Ms. ██████ signed FSCS plans and NOA given. FCM ██████ is requesting that this

Patient is a 7-month-old is brought in with head contusion and upper lip contusion. The history is that early this morning the child was awake as a child of his age would be he is placed back in his crib in the way was to be placed into his play with his a fairly heavy boy it was dark and the weight was inadvertently dropped in the 80s head. The baby would had immediate cry mother came in and pick up baby there was no loss of consciousness, no focal deficits, child has been acting completely appropriate. There seemed to be no problem with the baby at the time. The baby was placed back in the crib went to sleep quickly. Since that time the baby has been completely appropriate, but during the intervening morning hours bruising was noted around the ear but mainly on the upper lip right of midline and a small hematoma under knees the gumline on the hard palate. He brought the child in. We asked very direct questions including possible abuse. They state that they understood the questioning they knew it would probably calm but there was no evidence or sign of this. They are just concerned about the hematoma under the dental ridge.

Amount of bruising I did S. very direct specific questions about any child abuse they deny it he also knew the place of Vioxx because of the nature of the bruising but felt since this was not an issue they would come in and have it looked at. I was somewhat concerned about the degree of bruising but I see no other lesions whatsoever on the child. Do not feel at this time a state of abuse exists. S. case with mother and grandmother. I do not feel there is enough evidence to say a CT scan is necessary given the risks of that amount of radiation. Clinically we would not consider a intracranial pathology by presentation her history. They are in agreement and will followup as needed.
