- 1. Failure to obtain requested records on an expedited basis could reasonably he expected to pose an imminent threat to the life or physical safety of an individual; or
- 2. With respect to a request made by a person primarily engaged in disseminating information, urgency to inform the public concerning actual or alleged Federal Government activity.

You have not demonstrated that there is a particular urgency to inform the public about an actual or alleged federal government activity. Therefore, we have determined that your request for expedited processing is denied

You requested a waiver of processing fees. It has been determined that you are a representative of the news media. You are required to pay duplication costs after the first 100 free pages. Therefore, your request for a fee waiver has been denied.

If you are not satisfied with my response to this request, you may administratively appeal by writing to the Director, Office of Information Policy (OIP), United States Department of Justice, Suite 11050, 1425 New York Avenue, NW, Washington, DC 20530-0001, or you may submit an appeal through OIP's FOIAonline portal by creating an account on the following web site: https://foiaonline.regulations .gov/foia/action/public/home. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
