Title 11 of the United States Code, Section 110, subsection (c) requires a bankruptcy petition preparer to place an identifying mark on each document they prepare for filing. In the case of an individual the identifying mark shall be that persons social security number; and

Title 11 of the United States Code, Section 110, subsection (g) provides that a bankruptcy petition preparer shall not receive or collect from the debtor the court filing fees related to filing the petition.

Title 11 of the Untied States Code, Section 110, subsection (1) provides for a fine of up to \$1,500.00 for failure to comply with requirements of Section 110.

CARLOS SANTIAGO NUNEZ LA CRUZ IS ORDERED TO APPEAR at a hearing in this case on, January 31, 2012 at 9:00:00 AM, at 21041 Burbank Blvd., Woodland Hills, CA 91367, in Courtroom 302, to explain the relationship between Carlos Santiago Nunez La Cruz and Debtor; and explain why Carlos Santiago Nunez La Cruz failed to comply with 11 USC § (b), (c) and (g) and to show cause why he should not be fined.

If Carlos Santiago Nunez La Cruz was not involved in preparation of the doucments in this case, Carlos Santiago Nunez La Cruz is directed to bring information as to who gave the documents to Carlos Santiago Nunez La Cruz for filing, and who preprepared the documents Carlos Santiago Nunez La Cruz filed.

Failure to appear or to provide the information requested may result in an imposition of a fine under 11 USC \$110(1).
