NARRATIVE:

1 ON 06/15/2017 I, OFFICER M.C. GLUCK 1786, WAS DISPATCHED TO A BURGLARY AT 523 EMILY DR. THE CALL STATED THAT THE RESIDENTS WERE  
2 EVICTED AND SOMEONE WAS HEARD BUSTING THINGS AND MAKING A LOT OF NOISE.  
3 AS I ARRIVED ON SCENE I WAS ABLE TO HEAR VERY LOUD BANGING WHICH I DETERMINED TO BE GLASS BREAKING. I THEN HEARD A VEHICLE ENGINE  
4 START UP AND SAW HEADLIGHTS COMING FROM THE GARAGE. I SAW A WHITE HONDA ACCORD SLOWLY BEGIN TO DRIVE OUT OF THE DRIVEWAY. I  
5 YELLED "POLICE STOP" VERY LOUDLY AND THE SUSPECT LOOKED AT ME AND CONTINUED DRIVING. I ONCE AGAIN YELLED "POLICE STOP AND PUT  
6 YOUR HANDS UP," BUT THE SUSPECT MADE EYE CONTACT AND BEGAN TO DRIVE OFF. I WAS ABLE TO OBSERVE THAT THE WINDOWS TO THE VEHICLE  
7 WERE DOWN AS I WAS YELLING AT THE SUSPECT.  
8  
9 SGT. ACEVEDO 732 WAS ARRIVING ON SCENE AS THE VEHICLE BEGAN TO PULL OFF. SGT. ACEVEDO FOLLOWED THE VEHICLE AND IMITATED A TRAFFIC  
10 STOP AT EMILY DR AND KENNETH DR. I PULLED UP TO THE TRAFFIC STOP AND SGT. ACEVEDO WAS GIVING THE SUSPECT MULTIPLE VERBAL  
11 COMMANDS TO GET ON THE GROUND AND THAT HE WAS UNDER ARREST, BUT THE SUSPECT, MR. JEFFREY MATHIS, FAILED TO COMPLY AND WAS  
12 TASED. I WENT UP AND PLACED MR. MATHIS IN HANDCUFFS WHICH WERE CHECKED FOR FIT AND DOUBLE LOCKED.  
13  
14 MR. MATHIS SEEMED VERY DISORIENTED AND APPEARED TO HAVE MENTAL PROBLEMS OR BE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS. MR.  
15 MATHIS DENIED DRUG OR ALCOHOL USE (BESIDES HIS PRESCRIBED MEDICINES). MR. MATHIS CLAIMED THAT HE LIVED AT THE HOUSE AND DENIED  
16 BREAKING ANYTHING.  
17  
18 I READ MR. MATHIS HIS MIRANDA RIGHTS, BUT WHILE READING THEM HE CONTINUOUSLY INTERRUPTED ME.  
19  
20 I PLACED MR. MATHIS IN MY BACK SEAT AND ONCE HE WAS IN MY VEHICLE I ONCE AGAIN READ HIM HIS RIGHTS WITHOUT INTERRUPTION.  
21  
22 MR. MATHIS ADMITTED HE RECEIVED A DISPOSSESSORY NOTICE, BUT STATED HE WASN'T EVICTED YET. MR. MATHIS ALSO SAID HE DIDN'T HEAR ME  
23 BECAUSE HIS MUSIC WAS ON, ALTHOUGH NO MUSIC WAS HEARD FROM HIS VEHICLE WHEN I WAS GIVING HIM VERBAL COMMANDS.  
24  
25 PHOTOS OF THE DAMAGE TO THE HOUSE WERE TAKEN AND UPLOADED TO FORAY. AT THE TIME OF THIS REPORT NO CHARGES WERE MADE DUE TO  
26 BEING UNSURE OF EVICTION STATUS OR WHO THE CURRENT OWNER OF THE HOUSE IS.

28 MR. MATHIS WAS EVALUATED BY GWINNETT MED 3 ON SCENE AND THEN TRANSPORTED TO THE GWINNETT COUNTY JAIL WHERE HE WAS TURNED  
29 OVER TO THE ON DUTY BOOKING DEPUTIES.  
30  
31 MR. MATHIS'S VEHICLE WAS IMPOUNDED FROM THE SCENE.  
32  
33 I SPOKE TO THE ON DUTY MAGISTRATE WHO ISSUED A WARRANT FOR OBSTRUCTION.

35 NOTHING FURTHER WAS AVAILABLE AT THE TIME OF THIS REPORT.
