Dear Sir or Ma'am:

This is an appeal under the Freedom of Information Act.

On August 29, 2017 I requested, on behalf of SGM (Ret) Jean-Paul Courville ("Courville"), a complete copy of his C-File and a complete copy of documents and evidence created by the VA with regard to any Compensation & Pension Examination which relate to his claim for disability benefits pursuant to the Freedom of Information Act (FOIA) (attached). The fax transmission was successful and acknowledged by the Department of Veterans Affairs Records Management Center via a letter dated September 18, 2017 (attached). This acknowledgment letter advised me that the request "will be processed under the Privacy Act."

In my letter, I asked that the request for documents be processed under both the FOIA, 5 U.S.C. § 552, and the Privacy Act, 5 U.S.C. § 552a. 38 CFR § 1.550(c) states that "Requests for records relating to a claim administered by VA ... will be processed under the FOIA...." Further, 38 CFR § 1.550(b) provides that "requests for records about an individual protected by the Privacy Act ... will be processed under the FOIA and the Privacy Act." (emphasis added). Department of Justice overview of the Privacy Act, found at https://www.justice.gov/opcl/individuals-right-access, also notes that there is no practical effect of the FOIA and Privacy Act's differences with regard to processing timelines and administrative appeals because "agencies should process an individual's access request under both statutes."

The FOIA requires the agency make a determination on the request within twenty (20) business days from the date of VA's receipt of the request. 38 CFR § 1.557(c). The September 18, 2017 letter indicates that VA has not performed this required determination and, as such, is interpreted as a denial of release without justification. Please process this request under the FOIA and provide me a determination within the statutorily required twenty (20) business days.

This appeal is submitted within 60 days of the agency's September 18, 2017 letter denying the FOIA request and as such is timely pursuant to 38 CFR § 1.559(d).
