CONSENT DECISION AND ORDER AS TO RESPONDENT KEITH ROSBURY

This proceeding was instituted under the Horse Protection Act (15 U.S.C. § 1821 et

seq.)(HPA or Act), by a complaint filed by the Administrator, Animal and Plant Health Inspection Service, United States Department of Agriculture (APHIS), on January 12, 2017, alleging that the respondents violated the Act.

Respondent Keith Rosbury admits the jurisdictional allegations in the complaint, specifically admits that the Secretary has jurisdiction in this matter, neither admits nor denies the remaining allegations, and waives oral hearing and further procedure. The parties consent and agree to the entry of this decision for the purpose of settling this proceeding as to respondent Keith Rosbury, and resolving any and all other alleged or potential violations of the Act by him occurring up to and including September 4, 2017. This decision is entered pursuant to the consent decision provisions of the Rules of Practice applicable to this proceeding (7 C.F.R. § 1.138).

### Findings of Fact

1. Respondent Keith Rosbury is an individual residing in and at all times mentioned herein was a "person" and an "exhibitor," as those terms are defined in the regulations promulgated under the Act (9 C.F.R. Parts 11 and 12).


2. On or about August 27, 2016, respondent Keith Rosbury allowed the entry of a horse he owned (Gen's Black Maverick), for the purpose of showing the horse, in class 84A in a horse show in Shelbyville, Tennessee.

### Conclusion of Law


Respondent Keith Rosbury having admitted the findings of fact set forth above, and the parties having agreed to the entry of this decision, such decision will be entered.

### Order

- 1. Respondent Keith Rosbury is disqualified for four months, beginning January 1, 2018, and ending April 30, 2018, from showing, exhibiting, or entering any horse, directly or indirectly through any agent, employee, or other device, and from judging, managing or otherwise participating in any horse show, horse exhibition, or horse sale or auction, directly or indirectly through any agent, employee, or other device.
- 2. Respondent Keith Rosbury is assessed a civil penalty of \$550, which shall be paid by October 1, 2017, by check made payable to USDA/APHIS, indicating that the payment is in reference to HPA Docket No. 17-0172, and sent to:



1"Participating" means engaging in any activity beyond that of a spectator in connection with a horse show, horse exhibition, or horse sale or auction, and includes, without limitation, transporting or arranging for the transportation of horses to or from equine events, personally giving instructions to exhibitors, being present in the warm-up or inspection areas, or in any area where spectators are not allowed, and financing the participation of others in equine events.



Thanks for getting in touch with me and letting me know what's on your mind regarding harmful training practices in the walking horse industry.

In baseball, if a player illegally uses steroids, you punish the player – you don't shut down America's national pastime. With Tennessee Walking Horse shows, when trainers, owners or riders illegally sore a horse, we should find a more effective way to punish and stop them – not shut down one of Tennessee's most treasured traditions.

Yet, just one week before President Obama left office, the U.S. Department of Agriculture (USDA) announced a final rule, the "Horse Protection: Licensing of Designated Qualified Persons and Other Amendments," that could have had a significant negative effect on the Tennessee Walking Horse industry and the small businesses and communities benefiting from the industry. The final rule required USDA to assume responsibility for training, screening and licensing horse inspectors and banned the use of all action devices.

However, on January 20, 2017, President Trump issued a freeze on pending regulations, which was much like previous presidential transitions including those of Presidents Reagan, Clinton, Bush, and Obama. The memorandum directed all unpublished rules be withdrawn and sent back to the agencies for review. Since this rule was not published in the Federal Register, it has been sent back to USDA.

I support wiping out the contemptible and illegal practice of horse soring, not wiping out the century old tradition of showing Tennessee Walking Horses as the proposed rule could do. I, along with other members of Congress, introduced legislation last Congress that would end horse soring. I hope the new Secretary of Agriculture will work with Congress to enact legislation that punishes trainers, owners and riders who abuse horses while preserving the opportunity for law abiding horse embusiasts to participate in competitions that are the basis of the Tennessee Walking Horse industry.

I'm grateful you took the time to voice your concerns about the protection of the Tennessee Walking Washington and in Tennessee.


