Dear Mr. Law:

I write on behalf of myself and Matthew Stoller. We are independent journalists in the process of researching the policies of the Clinton Treasury Department under the leadership of Robert Rubin and Larry Summers. We request records under the provisions of the Freedom of Information Act, 5 U.S.C.§ 552.

Background

During the 2016 Presidential campaign, Facebook Chief Operating Officer and former Treasury Secretary Chief of Staff Sheryl Sandberg was reportedly under consideration for the position of Treasury Secretary by Democratic nominee Hillary Clinton.

Ms. Sandberg's tenure at Treasury coincided with Congress's passing of legislation that dramatically reduced regulation of the financial sector, leading to systemic issues that played a significant role in the financial crisis of 2008.

Given that Ms. Sandberg has great influence in the Democratic Party, her activities during her tenure at Treasury are highly relevant to the public and necessary to evaluate her record as a steward of the U.S. economy.

The records requested offer critical insight necessary for such evaluation.

Requests

We request the following records concerning former Treasury Secretary Chief of Staff Sheryl Sandberg:
