I am unable to provide any additional information. The receptacle data you are requesting is commercial in nature. The data provides sensitive information about how pieces of mail are transported from foreign posts to the Postal Service. This material is exempt from disclosure under FOIA Exemption 3, 39 U.S.C 410(c)(2).

If you are not satisfied with the response to this request, you may file an administrative appeal within 90 days of the date of this response letter by writing to the General Counsel U.S. Postal Service 475 L'Enfant Plaza SW Washington, DC 20260 or via email at FOIAAppeal@usps.gov. Your appeal must be postmarked or electronically transmitted within 90 days of the date of the response to your request. The letter of appeal should include, as applicable:

1. A copy of the request, of any notification of denial or other action, and of any other related correspondence;
2. The FOIA tracking number assigned to the request;
3. A statement of the action, or failure to act, from which the appeal is taken;
4. A statement identifying the specific redactions to responsive records that the requester is challenging;
5. A statement of the relief sought; and
6. A statement of the reasons why the requester believes the action or failure to act is erroneous.

Could I please request your assistance with the attached FOIA request, for which I received a response in the mail today? I am representing an elderly woman, *pro bono* (free of charge) who is the surviving spouse of a late WWII veteran and who lives in a rural part of the Philippines. It is important that I understand the complete "path" of a piece of registered air mail that she sent from the Philippines to the United States so that I potentially can argue to a veteran's appeals court here in DC that she filed her appeal on time when she mailed it to the Court.

As you can see from the attached FOIA response that I received this afternoon, there is a printout from the USPS Tracking Intranet for tracking number **RR066777197PH**. It is extremely hard to read that printout, but it might be helpful to us. Could you please email me a "print to pdf" (electronically printed) version that is legible so that I can read the details? Also, it appears that there is a "Receptacle ID" associated with the shipment of this letter from Manila, Philippines through Tokyo Narita. Could you please provide me with a printout of

all details concerning that Receptacle ID? I am trying to determine every stop that this letter took from the Philippines to Washington, DC. I also am trying to determine exactly at what point the letter was in the possession of USPS.
