This letter responds to your September 11, 2017 request:

I am requesting three files that I have submitted in previous TCR tips (and potentially emails) to the SEC. The files are numbered in order and all contain the word base "Bsylum." I respectfully request that you take prompt action to search through my TCR tips for all tips containing attachments that contain the text "Bsylum" and disclose those attachments to me.

After consulting with other SEC staff, I have determined that because of the time necessary for processing your request, it is being placed in our complex track. Under 5 U.S.C. § 552(b)(6)(D)(i) agencies may provide for multi-track processing of requests for records based on the amount of work or time (or both) involved in processing requests. The SEC's regulation implementing multi-track processing is located at 17 CFR § 200.80(d)(5).

At present we anticipate that it may take thirty-six months or more before we can begin to process a request placed in our complex track.
