To Whom It May Concern:

I'm a 38-year-old attorney and author with a personal and professional history of political and legal action advocating for civil and constitutional rights. I began my legal career litigating for Judicial Watch. My passion for exposing government corruption and abuse of power only grew as I moved on to run my own solo firm, representing clients in California, Oregon, and Washington in matters ranging from entertainment law to business, employment (especially anti-discrimination cases), and real estate, always with an emphasis on helping citizens protect their rights and obtain justice. I am deeply honored to have been recommended for appointment to the position of Assistant Secretary for Civil Rights (Department of Education) in this historic and inspiring Trump Administration.

I authored the seminal book exposing the hypocrisy and abuse of women perpetrated by Bill and Hillary Clinton, titled "[Their Lives: The Women Targeted by the Clinton Machine](#)," published in 2005 by World Ahead Publishing (now WorldNetDaily.com). Alongside my private legal practice, I've been a [nationally-featured speaker](#) and interviewee on topics of abuse of government power (by the Clintons in particular) with [numerous scholarly articles](#) to my name.

In the 2016 presidential election, I was inspired from day one of Donald J. Trump's candidacy to dedicate all my energy, expertise, and ability to helping his movement achieve victory by directing public attention to Hillary Clinton's lifelong pattern of corruption and abuse of power. I have been all-aboard the Trump Train from the moment he announced his candidacy, and I'm proud of the contributions I made during this election. I founded a 501(c)(4) social welfare organization, [Their Lives Foundation](#), dedicated to giving voice to victims of abuse of official power, and specifically represented rape victim Kathy Shelton, who joined me in sharing her story of victimization at the hands of Hillary Clinton to expose Mrs. Clinton's hypocrisy, deception, and corruption. Highlights of my election efforts include (i) accompanying Kathy Shelton as [an invited Trump campaign VIP guest to the Second Presidential Debate](#) alongside my longtime friends Juanita Broadrick, Kathleen Willey, and Paula Jones; (ii) arranging [numerous media interviews](#) for Kathy Shelton and myself to convey the trauma and significance of her abuse by Hillary Clinton, including shooting ads with Kathy Shelton in Arkansas at the direct request of the Trump campaign; (iii) investigating and [uncovering new evidence](#) related to Hillary Clinton's malfeasance in the Kathy Shelton case, and (iv) producing and digitally distributing [ads](#) and [videos](#) designed to expose Hillary Clinton's corruption. Media moguls like Sean Hannity, Alex Jones, and Dinesh D'Souza worked with me enthusiastically during this election.

I firmly believe that confronting Hillary Clinton on her hypocrisy as a "champion for women and children" by drawing attention to her abysmal record covering up for her husband's sexual crimes and her own voluntary choice to break rules in order to let a child rapist go free was a message worthy of fighting for in this election; at a minimum, strategically, that message helped neutralize the bogus, manufactured lies about President Trump's treatment of women. I'm proud of what I accomplished; with few resources, I demonstrated incredible dedication and resourcefulness to reach mass audiences with this strategic message and I believe, at the margins, it contributed to the Trump campaign's better-than-predicted success with female voters.

I'm a lifelong conservative Republican, with a philosophical bent toward libertarianism. I graduated with honors with a degree in Economics from Stanford University, and with honors from Pepperdine University School of Law as a Faculty Scholar with a full-tuition scholarship. I graduated high school at age 16 and college at age 20. I managed my father's congressional campaign in 1998 (hiring Kellyanne Conway as a pollster) after training in campaign management through the RNC and Morton Blackwell's Leadership Institute. Although my father's congressional bid was unsuccessful, receiving endorsement from David Horowitz was a highlight of that experience. David Horowitz

is a longtime friend of my brothers [Jonathan Jackson](#) and [Richard Lee Jackson](#), who allied with Mr. Horowitz's Conservatives In Hollywood consortium for many years. (My brothers are accomplished actors and musicians, including multiple Emmys, and they remain steadfast conservative Christians in Hollywood and Nashville.)

I worked in D.C. for Congresswoman Linda Smith, and for a Republican state senator in Olympia, WA. At age 18, I was the youngest person ever elected as a presidential elector in Washington State history. During my years at Stanford, I worked for Pacific Research Institute in San Francisco and had several op-eds published, working closely with scholars Sally Pipes and Lance Izumi. My parents are fervent constitutional conservatives, and my father has continued his career as a successful family-practice physician fighting against Obamacare. My father, Dr. Ricky Lee Jackson, is also a talented musician and I arranged for him to perform his original song "[Freedom Family and Faith](#)" at both the National Doctor's Teaparty and live on Fox & Friends.

I'm a devout Christian and my life is governed by traditional values, even though some may see me as unconventional due to the fact that I'm a lesbian married to a wonderful, brilliant woman (also an attorney) who happens to be a lifelong Democrat and Hillary Clinton supporter. Our Carville/Matalin dynamic gives me a unique foundation for communication and exchange of ideas with political "opponents" from a perspective of genuine respect and rationality. Hello Candice,

First of all welcome aboard! I realize you're likely still working to get settled at the Department and learning various aspects of your new role in OCR.

I work in the Secretary's scheduling office here in OS with Sarah Delahunty and Dougie Simmons. They asked that I obtain your recommendation for the attached meeting requests for the Secretary. These three groups- Families Advocating for Campus Equality (FACE), SurvJustice, and End Rape on Campus, are requesting to discuss various aspects of campus sexual assault laws and Title IX enforcement.

FACE is requesting a meeting with the Secretary specifically on either April 24th or April 25th to discuss their concerns with campus sexual assault laws and Title IX enforcement overreach. They asked several of their members to write to the Secretary at the same time (attached are some of the individual meeting requests on behalf of FACE) and we're getting phone calls from them pretty much every day to secure a meeting.

SurvJustice is requesting a meeting sometime this month to share their perspective on campus sexual assault laws, Title IX, and the Clery Act through their work with survivors of campus sexual assault.

Finally, End Rape on Campus is seeking a meeting with the Secretary sometime this month as well to emphasize their support for strong Title IX enforcement.

When you get a chance, can you please review the attached documents and let us know whether you think the Secretary needs to meet with these groups? If not, do you believe another Department official should meet with them including officials in OCR? Or should we simply decline?

Sandra Battle, who I'm sure you know served as Acting Assistant Secretary for OCR, made an initial recommendation below before you came on board. Let me know if your thoughts on that as well.
