Hello, Mr. Yerxa:

I hope you are doing well. I am the attorney tracking this FOIA request for my organization. I have a few follow up questions regarding the documents that you sent on January 25, 2018.

- The response is titled an "interim response." It states that the 98 pages of released records are responsive to numbers 1, 3, and 4(a) of our request. However, the response also contains appeal language. Does this mean that the letter is intended to be a final response to the request?
- As a related question, is DOL still continuing to search for records that are responsive to numbers 2, 4(b), 4(c), and 4(d)? In other words, should I be expecting another response from you relating to these requests (e.g., SF-50 forms, any conflicts or ethics waivers, any recusals, names of all career employees who have been detailed into a leadership office or component?
