Re: Appeal of Termination of Employment Wesley J. Hensley

Dear Mr. Hunt:

Pursuant to his rights under the Peace Officers Bill of Rights, and §§1007 *et seq.* of the City of Tulare Merit System Rules and Regulations, former Police Chief Wes Hensley hereby appeals the Notice of Termination from Employment served by email on his attorney at 4:24 p.m. on Tuesday, March 20, 2018.

This appeal will be based on the following procedural and substantive grounds:

- 1. Mr. Hensley was never served with a Notice of Proposed Termination of Employment;
- 2. Mr. Hensley was denied a *Skelly* hearing prior to the termination of his employment;
- 3. Mr. Hensley was never furnished with a copy of any materials upon which the termination of his employment was based;

- 4. Mr. Hensley was denied both procedural and substantive due process regarding his termination;
- 5. The stated grounds for Mr. Hensley's termination were not true at any time prior to the termination of his employment;
- 6. The Notice of Termination from Employment was the product of unlawful pressure designed to obstruct justice; and
- 7. The Notice of Termination from Employment was the product of political corruption engaged in by certain City officials.

As you may be aware, Mr. Hensley has previously indicated that he will waive his right to privacy, and hereby demands that his Administrative Appeal be conducted in a public setting, open to both the press and interested citizens.

It is our estimate that this hearing will take three to four full days. In that regard, we currently anticipate calling the following witnesses (more may be added as we prepare for the hearing):
