Thank you for your response.

I note that 5 U.S.C. 552(a)(6)(B)(i) allows for a ten-day extension when "unusual circumstances" exist, but also requires that the requestor be given the "date on which a determination is expected to be dispatched."

Almost nine months have elapsed since my FOIA request, but I have not received a date on which I can expect a determination on my request.

Additionally, the ten-day extension may not be extended further absent "exceptional circumstances" which do "not include a delay that results from a predictable agency workload of requests under this section, unless the agency demonstrates reasonable progress in reducing its backlog of pending requests." 5 U.S.C. 552(a)(6)(C)(ii).
