As we discussed, I am currently considering whether to limit my request to final legal opinions and communications with individuals outside the federal executive branch—with the understanding that the latter would potentially be covered by attorney client privilege (but not attorney work product) and the latter would be unprivileged. My understanding is further that you are checking with the FOIA counsel about the practicality of searching for communications with individuals outside the federal executive branch.
