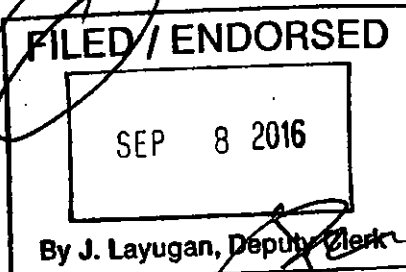

ORDER REGARDING TEMPORARY RESTRAINING ORDER

Take notice that the Court hereby orders the Temporary Restraining Order issued on _____ will remain in effect pending the hearing or trial date above.

Take notice that the Court hereby continues the hearing. No temporary orders are in effect.

- The Temporary Order is modified to a conduct-only order. No stay-away orders are in place.**
 - The restrained party shall not harass, attack, strike, threaten, assault (sexually or otherwise), hit, follow, stalk, molest, destroy personal property, disturb the peace, keep under surveillance, impersonate (on the Internet, electronically or otherwise), or block movements.
 - The restrained party shall not contact (directly or indirectly), or telephone, or send messages or e-mail.
 - The restrained party shall not take any action, directly or through others, to get the addresses or locations of any protected persons or of their family members, care takers or guardians.

The Temporary Order is modified to include a stay-away order. The restrained party shall stay _____ yards away from: the protected party; other persons protected by this order; home, job, vehicle of the protected party; the children(s) school or child care;
 Other orders of modification as follows: **NOT POST PHOTOGRAPHS, VIDEOS, OR INFORMATION ABOUT PETITIONER TO ANY INTERNET SITE AND TO REMOVE THE SAME FROM ANY INTERNET SITE OVER WHICH HE HAS ACCESS OR CONTROL**
