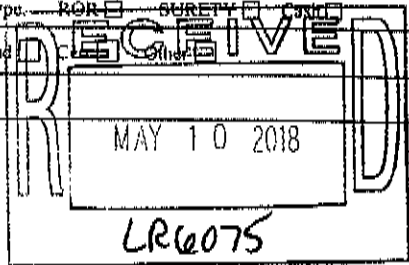

PROBABLE CAUSE AFFIDAVIT: (specify probable cause for each charge)  
 Before Me, the undersigned authority personally appeared A. RITZ who being duly sworn, alleges, on the information and belief, that on the 4 day of MAY, 2018, in Marion County, Florida, the defendant did:

Knowingly or willfully commit the offense of Trespass on School Grounds while at High School located at 7 NW 28th Street, Ocala, Marion County, Florida. To wit:

On Friday, May 4th, 2018 I was assigned as a School Resource Officer assigned to High School located at 7 NW 28th Street.


I made contact with [redacted] in the discipline office at [redacted] She stated she had a verbal altercation at her residence with Justin Watkins.


She stated she made the decision to leave the residence in her vehicle and head to school but Justin took her cell phone. He then drove away from her residence and she followed behind him in her vehicle. She stated she observed Justin throw something outside of the window which appeared to be her phone. She stopped and collected what she found out to be her screen protector. She stated she pulled into a gas station located at NE 49th Street and Ne Jacksonville Road. [redacted] stated Justin pulled into the gas station as well. She asked for her cell phone back which he purposefully threw on the ground causing the screen to shatter. She stated she collected her phone and drove to school in her vehicle. I was advised Justin followed behind her in his vehicle even when she pulled into the student parking lot of High School. She pulled into a parking space and Justin pulled in behind her in a white SUV. She stated Justin then started to kick her vehicle in several locations. Justin also attempted to let the air out of her passenger rear tire, but she stopped him. She stated he appeared to be escalating his behavior so she left the parking lot to get away from him. [redacted] stated after this Justin got into his vehicle and drove off. I was advised at this time it did not appear that there was any damage on her vehicle.

I made contact with Dean of Students, Kim Panitzke, who allowed me to review the school cameras. I observed a subject identified as Justin, kicking at a smaller four door car which was identified as [redacted] vehicle. Justin kicks several area's of the vehicle and does let some air out of the vehicle's tire. I was advised Justin is not a student at Vanguard High School and has no legitimate purpose on this school campus.

Since [redacted] phone was broken in an area outside of the City Limits I advised her to contact the Marion County Sheriff Office to make a report. I also advised [redacted] of the process of obtaining a restraining order. Since Justin was not a student at High School and has no legitimate purpose for being on the school campus, I feel there is probable cause for his arrest. I created a probable cause affidavit in reference.
