There may be a fee assessed for your request. Provisions of the FOIA allow us to recover part of the cost of complying with your request. If fees are applicable, we shall charge you for records in accordance with the Department of Health and Human Services (HHS) FOIA Regulations as they apply to "commercial-use" requesters – i.e., you would be charged for duplication at 10-cents per page; and for search and review time at the hourly rate of the searcher and reviewer (\$23.00, \$46.00 and \$83.00). Please be advised that the HHS FOIA Regulations allow us to charge for search time even if we do
