# INMATE TELECOMMUNICATIONS AGREEMENT AMENDMENT NUMBER 2

This Addendum, dated the 15th of 12 Cfmbl 2017, between Butts County of the one part, hereinafter collectively "County," and Pay Tel Communications, Inc. of the other part, hereinafter "Pay Tel" modifies the Inmate Telecommunications Agreement dated January 7, 2013 as amended by the Regulatory Compliance Amendment dated January 13, 2014 and by Amendment 1 dated August 20, 2015 (hereafter collectively referred to as the "Agreement").

For and in consideration of the mutual promised and covenants contained herein, Pay Tel and County hereby agree to modify the Agreement as follows:

- 1. 3.0 Term. The current term ending January 6, 2020 will be extended two (2) years, to and including January 6, 2022. After the renewed term, this Agreement shall be automatically renewed for successive five (5 year terms unless written notice of intent to terminate is given by either party no more than 120 days and not less than 60 days prior to the expiration of the then current term. Section 3.1 of the Agreement is deemed amended consistent with the foregoing.
- 4.0 Commissions. The commission payment shall be the following percentage of gross billable local, IntraLATA intrastate and InterLATA intrastate revenues: fifty percent (55%) effective beginning the first full month of service following execution of this Addendum.

Section 4.0 is hereby further amended to include the following additional section. .

- 4.4 The inteleMESSAGE™ commission payment paid shall be 20% of the gross message revenue.
- 3. 5.0 Equipment and Services Provided by Pay Tel. This section is hereby expanded to include the provision of inteleTABLET<sup>TM</sup> inmate educational tablets.
  The inteleTABLET<sup>TM</sup> deployment will begin with an initial quantity of 91 Inmate Hand-held tablet devices featuring the Edovo Educational suite), secure inmate messaging and the ability to make phone calls. Pay Tel will also provide the necessary quantity of charging stations for the

tablets. The equipment will be installed and maintained by Pay Tel with no up-front cost to County as further detailed in Attachment A to this Addendum.

  - o CaseMaker Law Library (provided by Pay Tel at no charge to Butts County)

- inteleMESSAGE™ Inmate Messaging: \$0.50 per message

### Recurring Fee Charged to County:

• Internet bandwidth cost of \$160 will be deducted from commissions each month
