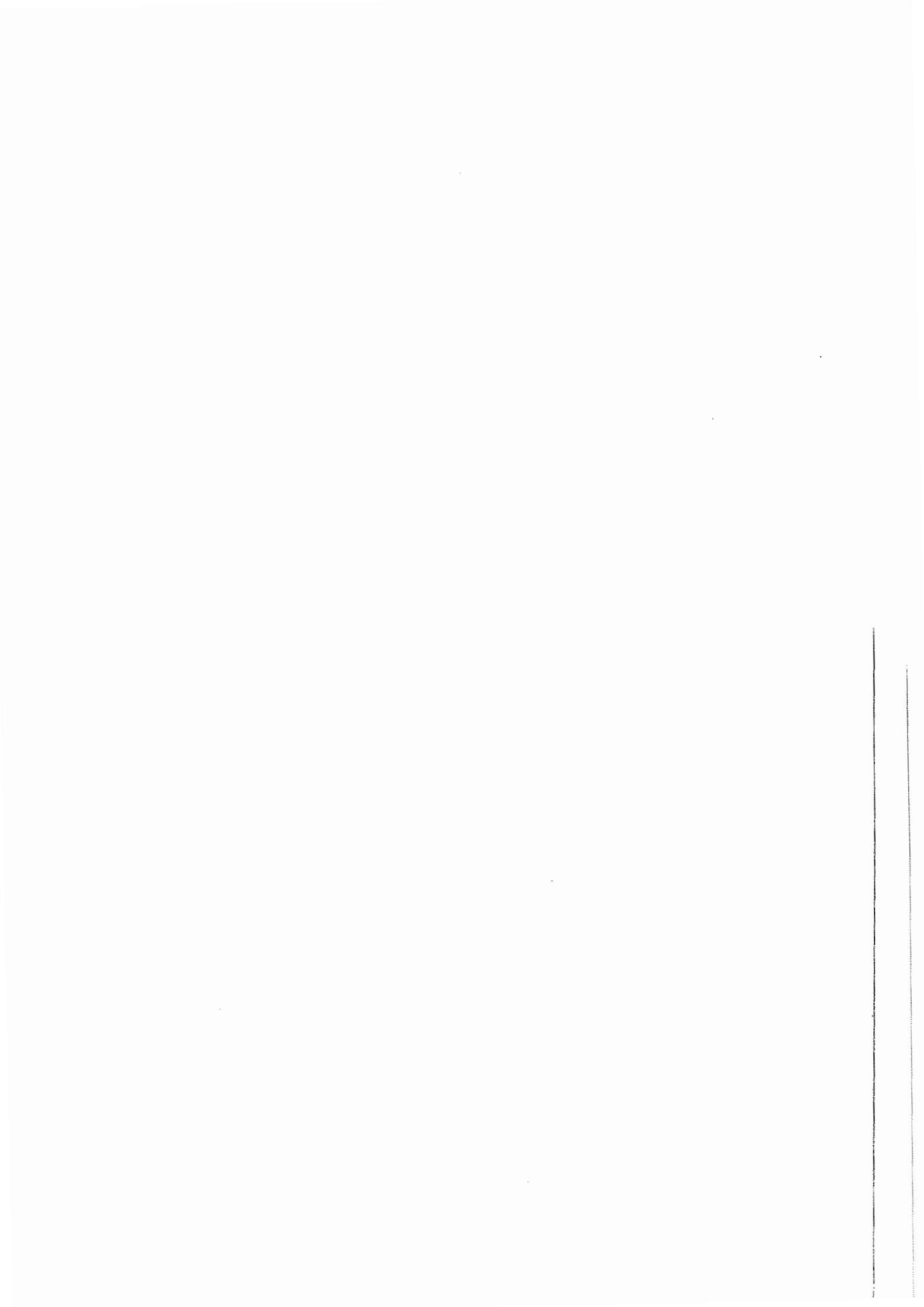

Dear Anna,

The Scottish Government has received a request under the Freedom of Information (Scotland) Act 2002 (FOISA) for:

- Any advice or other material (whether internal or external) regarding the role of the GTCS and/or proposed replacement of the GTCS
- Any communication (whether internal or external) regarding the role of the GTCS and/or the proposed replacement of the GTCS
- Details - including all supporting documents - of any meetings at which the role of the GTCS and/or proposed replacement of the GTCS was discussed

You have an interest in the information which has been requested as it includes extracts of our correspondence with you.

Therefore, I am writing to ask you for your views on whether this information should be disclosed before we make a decision on the request. Please note that this consultation is a courtesy, not a statutory obligation, and you do not have a veto on disclosure of the information. I have attached this piece of correspondence for your consideration.

Under the terms of FOISA, the decision on whether or not to release the information is for the Scottish Government alone. However, we will take account of your views.

I should also explain that we can withhold information only if an exemption under FOISA applies to that information and, where applicable, the public interest in disclosure is not outweighed by the public interest in upholding the exemption. Empowering Schools Consultation

I was very surprised and disappointed to find that the *Empowering Schools* consultation was published today by Scottish Government with no prior notice or discussion. This consultation specifically proposes to remove the regulation of people working in early years from my organisation and place it with the new Education Workforce Council. Those workers make up a third of the SSSC's Register at present, and have sat with us since our establishment in 2001. We had no warning of this and the consultation contains no rationale or timescales, indeed both the SSSC and the early years' workforce get little more than a cursory mention despite the significance of this change.

When the original consultation was published earlier this year, I was aware that the SSSC came within scope of the education governance review because of our role in regulating early years workers. At that time, I had a conversation with Fiona Robertson who assured me that while this was under consideration, it was unlikely to go any further for at least 2 years if at all, as there was no desire to make change for change's sake. You may recall a meeting with you that I attended with other stakeholders with a national remit last Christmas; this wasn't mentioned.

To be clear, I have no issue with the regulation of early years workers being moved to the new body if that is the right thing for those workers and for children, and we will respond to the proposals set out in the consultation. The reason I am writing to you is about how badly this has been handled by officials and how taken aback I am by the content and language in section 5, the Education Workforce Council.



I will deal firstly with how this has been handled. The first I heard about the publication of this consultation was when I got a message to phone a Tracy Manning in the Learning Directorate at 11.30 am yesterday by which time it had already been published. I have also spoken to our sponsor team in the Office of the Chief Social Work Adviser who likewise hadn't been advised of the launch. I have had no contact from anyone in Scottish Government about this since June, and the impression I was given then was that the regulation of the early years workforce was unlikely to be a priority any time soon. So I am very surprised to see it explicitly mentioned in *Empowering Schools*.

Early years workers make up a third of our registrants, at present at just under 40,000 people. We will now have to deal with all the questions that will arise for the sector having had no time to prepare and with no information or rationale. We have had to come up with lines for our Enquiries team and other staff who are in regular contact with the sector. It makes government look high handed and we look like we have been sidelined. Registrants will be worried about fees, about renewing their registration, about whether the qualifications they've spent the last ten years achieving will still be relevant. People naturally go to the things that impact on them most immediately and when there is no information they fill that vacuum with speculation. None of us need that.

I have also had to communicate with our staff who have seen a significant chunk of our work across all our functions, not just regulation, called into question. They will be asking what it means for their jobs. I was told on the phone that there is unlikely to be any change for up to five years, and I will tell people that, but there is nothing in the published document to confirm that.

Secondly, I will address the content and the language used in the consultation, particularly Section 5.

The wording of the consultation is extremely unhelpful. It says both overtly and implicitly that only teachers have had any work done on raising professionalism, raising qualification levels and skills when this is clearly not the case. The early years workforce have invested hugely as individuals, as have their employers (not just local authorities; the majority of early years provision is in the private and voluntary sector) and national bodies such as the SSSC, Early Years Scotland and the Scottish Child-minders' Association. Over the last ten years they have gone from having few qualifications to being one of the most qualified parts of the social service workforce and every manager has to have a degree. Unlike some other parts of our Register, this workforce has embraced the up-skilling agenda wholeheartedly and we can see the positive impact on the workers, but also on children and young people. I object in particular to this sentence on page 26 which simply isn't true:

"While there has been a clear acceptance of the importance of teacher professionalism, and therefore investment in teacher professional development, this has not been replicated across the wider education workforce."


The consultation uses the term "non-teachers" throughout. This is something local government moved away from about 20 years ago. People working in schools, or anywhere else, are professionals in their own right; they aren't defined by the fact they aren't teachers.

In my view, Section 5 of the *Empowering Schools* is disrespectful to the SSSC and more importantly to the early years' workforce.

When I spoke to Ms Manning, she assured me that no changes were planned in the near future. However, the genie is out of the bottle and it is the SSSC that will be left to handle the questions and uncertainties both for the sector and for our own staff. This could so easily have been avoided. There has been plenty opportunity for officials to communicate directly with me or my colleagues, or through our sponsor team. Our then Minister, Mark MacDonald came to meet with our Council Members last week and didn't mention this at all, which makes me wonder if even he was aware of it.

I hope you will recognise why I'm so disappointed and taken aback by this and that things will change in the future.

REASON FOR NOT PROVIDING INFORMATIONAn exemption applies

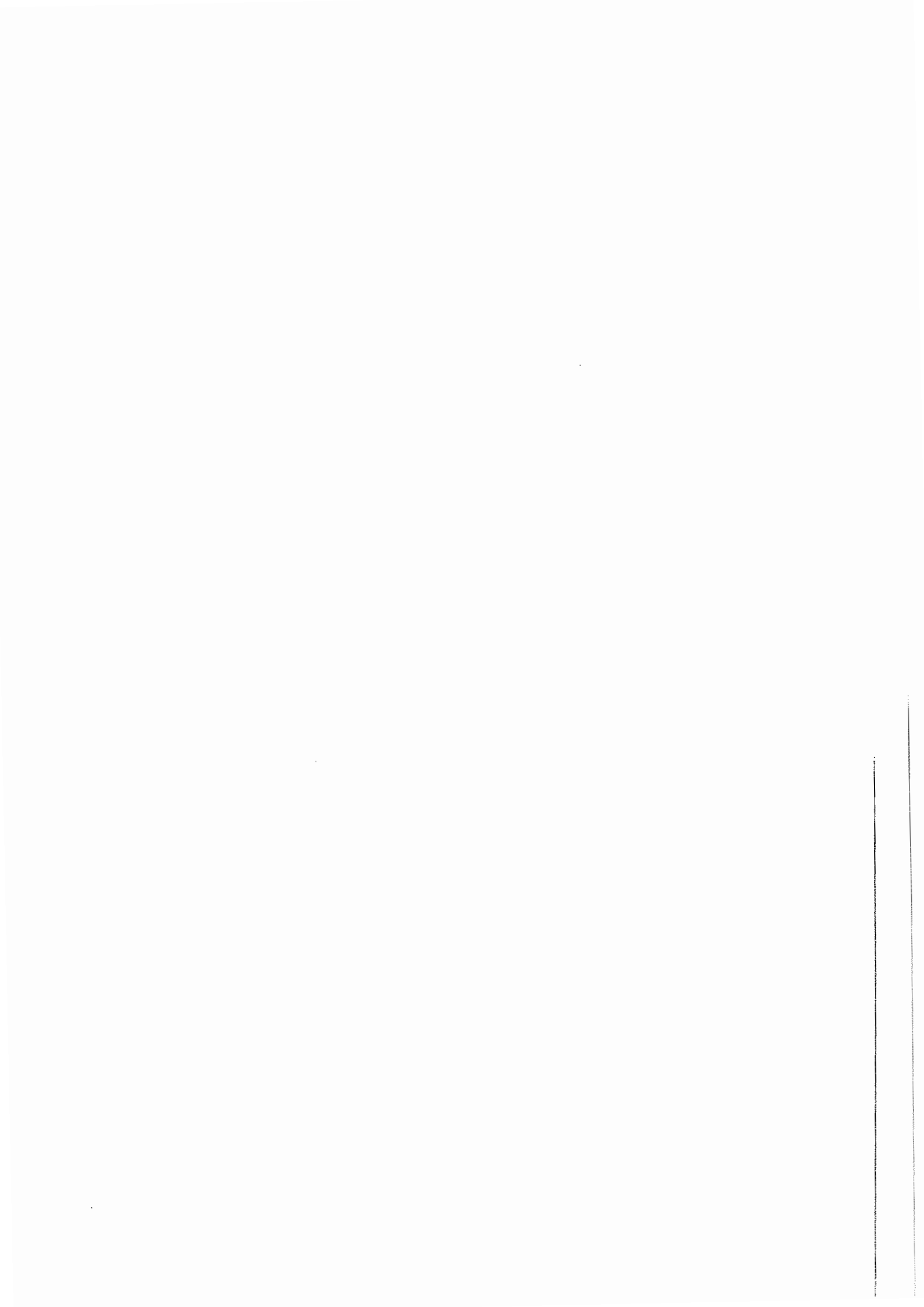
An exemption under section 38(1)(b) of FOISA (personal information) applies to some of the redacted information because it is the personal data of third party, i.e. names/contact details of individuals, and disclosing it would contravene the data protection principles in Schedule 1 to the Data Protection Act 1998. This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption.

An exemption applies, subject to the public interest test

An exemption under section 29(1)(a) (formulation or development of Scottish Government policy) and 29(1)(c) (Law Officers' advice) of FOISA.

An exemption under section 30(b)(i) of FOISA (free and frank provision of advice) and 30(b)(ii) (free and frank provision of views) applies to some of the redacted information. This exemption applies because disclosure would, or would be likely to; inhibit substantially the free and frank provision of advice and views. This exemption recognises the need for officials to have a private space within which to provide free and frank advice/views to Ministers on key discussion points in pre-meeting briefings. Disclosing the content of free and frank advice on such key points will substantially inhibit the provision of such advice in the future, particularly when these discussions relate to a policy matter, such as the Governance Review which is still on-going and where decisions have not been taken.

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open, transparent and accountable government, and to inform public debate. However, there is a greater public interest in allowing a private space within which officials can provide full and frank advice to Ministers, before they meet key stakeholders.

Thanks. As discussed when a response is issued under FOISA we are considered to have complied with our obligations under the Act and are only required under the act to re-visit this response if the applicant ask for a review of our response.

However we would consider it to be good practice that when further information is identified which would have fallen within the scope of a **very recent request** which was not considered for release but is subsequently being released in response to a request from a different applicant to highlight the release to the original applicant, however, as discussed there is no specific requirement under FOISA to do so and therefore it would be a case by case decision. I am aware that this has happened before, but is not something which happens regularly. I can only think of a couple of times in the last few years (in most cases all of the information is identified, or because of the passage of time the previous release is not considered).

There is no formal guidance which confirms the above, our requirement under FOISA is met by providing the response and the Act assumes that we will have identified all of the relevant information in doing so, or that the applicant will ask for a review.

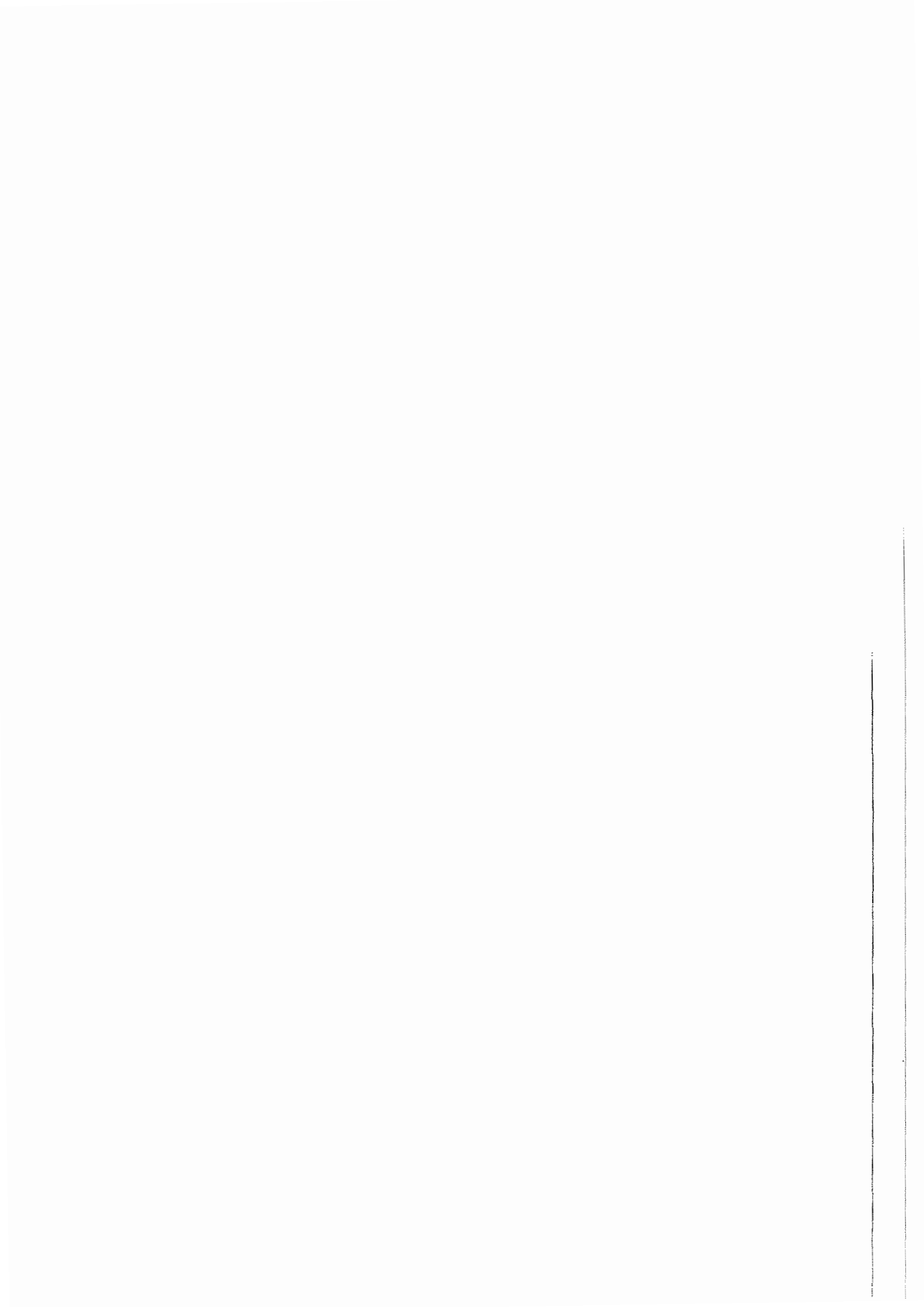

Thank you for your letter dated 8 November regarding the *Empowering Schools: A Consultation on the Provisions of the Education (Scotland) Bill* which I launched on 7 November.

I understand the concerns you raise regarding the substance of the proposals around the creation of the Education Workforce Council, and particularly the manner in which you were informed of these proposals. I appreciate that you will have found this situation frustrating.

Firstly, I would like to address the policy underpinning the creation of the Education Workforce Council. I am committed to establishing an Education Workforce Council to take on the responsibilities of the General Teaching Council for Scotland and the Community Learning and Development Standards Council and to register other education professionals and practitioners. I believe the establishment of such a Council could contribute to enhancing the quality of learning and teaching in Scotland by bringing coherence to the skills and standards which underpin our education professionals and practitioners.

You are right to note that the commitment of the early years workforce to raising qualification levels and skills over the last 10 years has been remarkable and the work of the Scottish Social Services Council has been key in supporting this. Our early years workforce is integral to delivering our commitment to the near doubling of the entitlement to Early Learning and Childcare (ELC) from 600 to 1140 hours per year from August 2020. I do not need to reiterate that this is one of the most important and transformational changes we are making during our current Parliamentary programme.



Earlier in November, we published *A Blueprint for 2020: The expansion of early learning and childcare in Scotland: Quality Action Plan*, this action plan reaffirms what experience and the research evidence tells us about what drives quality in ELC. The most important factor is that ELC is delivered by a profession that is dedicated to the care, learning and development of our youngest children. The actions set out in the plan demonstrate our strong commitment to investing in its professional identity and development. The Scottish Social Services Council

has been instrumental in every aspect of supporting our plans for expansion and I am grateful for your on-going commitment to this agenda.

As the consultation document sets out we are seeking views on which education professionals and practitioners should be included within scope of the Education Workforce Council. Given the opportunity which the Education Bill provides, I think it is essential that we consider the education workforce as broadly as possible and I will carefully consider your views on this issue alongside other consultation responses. As you allude to in your letter there may be longer term strategic benefits of aligning the early years workforce with the new Council, however I would not wish to risk unnecessary disruption in the short term.

An Education Workforce Council Strategic Working Group has been established with relevant stakeholders from GTCS and the Standards Council for Community Learning and Development for Scotland to consider the implications associated with the immediate establishment of the Council. I know my officials have discussed how you might engage with this work and I hope this is something you are open to.

I value your willingness to engage with us on this very important agenda, and I would like to reassure you that every effort will be made to ensure you are fully involved and informed as we progress through the consultation process and beyond. Empowering Schools Consultation

I was very surprised and disappointed to find that the *Empowering Schools* consultation was published today by Scottish Government with no prior notice or discussion. This consultation specifically proposes to remove the regulation of people working in early years from my organisation and place it with the new Education Workforce Council. Those workers make up a third of the SSSC's Register at present, and have sat with us since our establishment in 2001. We had no warning of this and the consultation contains no rationale or timescales, indeed both the SSSC and the early years' workforce get little more than a cursory mention despite the significance of this change.

When the original consultation was published earlier this year, I was aware that the SSSC came within scope of the education governance review because of our role in regulating early years workers. At that time, I had a conversation with Fiona Robertson who assured me that while this was under consideration, it was unlikely to go any further for at least 2 years if at all, as there was no desire to make change for change's sake. You may recall a meeting with you that I attended with other stakeholders with a national remit last Christmas; this wasn't mentioned.

To be clear, I have no issue with the regulation of early years workers being moved to the new body if that is the right thing for those workers and for children, and we will respond to the proposals set out in the consultation. The reason I am writing to you is about how badly this has been handled by officials and how taken aback I am by the content and language in section 5, the Education Workforce Council.



I will deal firstly with how this has been handled. The first I heard about the publication of this consultation was when I got a message to phone a Tracy Manning in the Learning Directorate at 11.30 am yesterday by which time it had already been published. I have also spoken to our sponsor team in the Office of the Chief Social Work Adviser who likewise hadn't been advised of the launch. I have had no contact from anyone in Scottish Government about this since June, and the impression I was given then was that the regulation of the early years workforce was unlikely to be a priority any time soon. So I am very surprised to see it explicitly mentioned in *Empowering Schools*.

Early years workers make up a third of our registrants, at present at just under 40,000 people. We will now have to deal with all the questions that will arise for the sector having had no time to prepare and with no information or rationale. We have had to come up with lines for our Enquiries team and other staff who are in regular contact with the sector. It makes government look high handed and we look like we have been sidelined. Registrants will be worried about fees, about renewing their registration, about whether the qualifications they've spent the last ten years achieving will still be relevant. People naturally go to the things that impact on them most immediately and when there is no information they fill that vacuum with speculation. None of us need that.

I have also had to communicate with our staff who have seen a significant chunk of our work across all our functions, not just regulation, called into question. They will be asking what it means for their jobs. I was told on the phone that there is unlikely to be any change for up to five years, and I will tell people that, but there is nothing in the published document to confirm that.

Secondly, I will address the content and the language used in the consultation, particularly Section 5.

The wording of the consultation is extremely unhelpful. It says both overtly and implicitly that only teachers have had any work done on raising professionalism, raising qualification levels and skills when this is clearly not the case. The early years workforce have invested hugely as individuals, as have their employers (not just local authorities; the majority of early years provision is in the private and voluntary sector) and national bodies such as the SSSC, Early Years Scotland and the Scottish Child-minders' Association. Over the last ten years they have gone from having few qualifications to being one of the most qualified parts of the social service workforce and every manager has to have a degree. Unlike some other parts of our Register, this workforce has embraced the up-skilling agenda wholeheartedly and we can see the positive impact on the workers, but also on children and young people. I object in particular to this sentence on page 26 which simply isn't true:

"While there has been a clear acceptance of the importance of teacher professionalism, and therefore investment in teacher professional development, this has not been replicated across the wider education workforce."


The consultation uses the term "non-teachers" throughout. This is something local government moved away from about 20 years ago. People working in schools, or anywhere else, are professionals in their own right; they aren't defined by the fact they aren't teachers.

In my view, Section 5 of the *Empowering Schools* is disrespectful to the SSSC and more importantly to the early years' workforce.

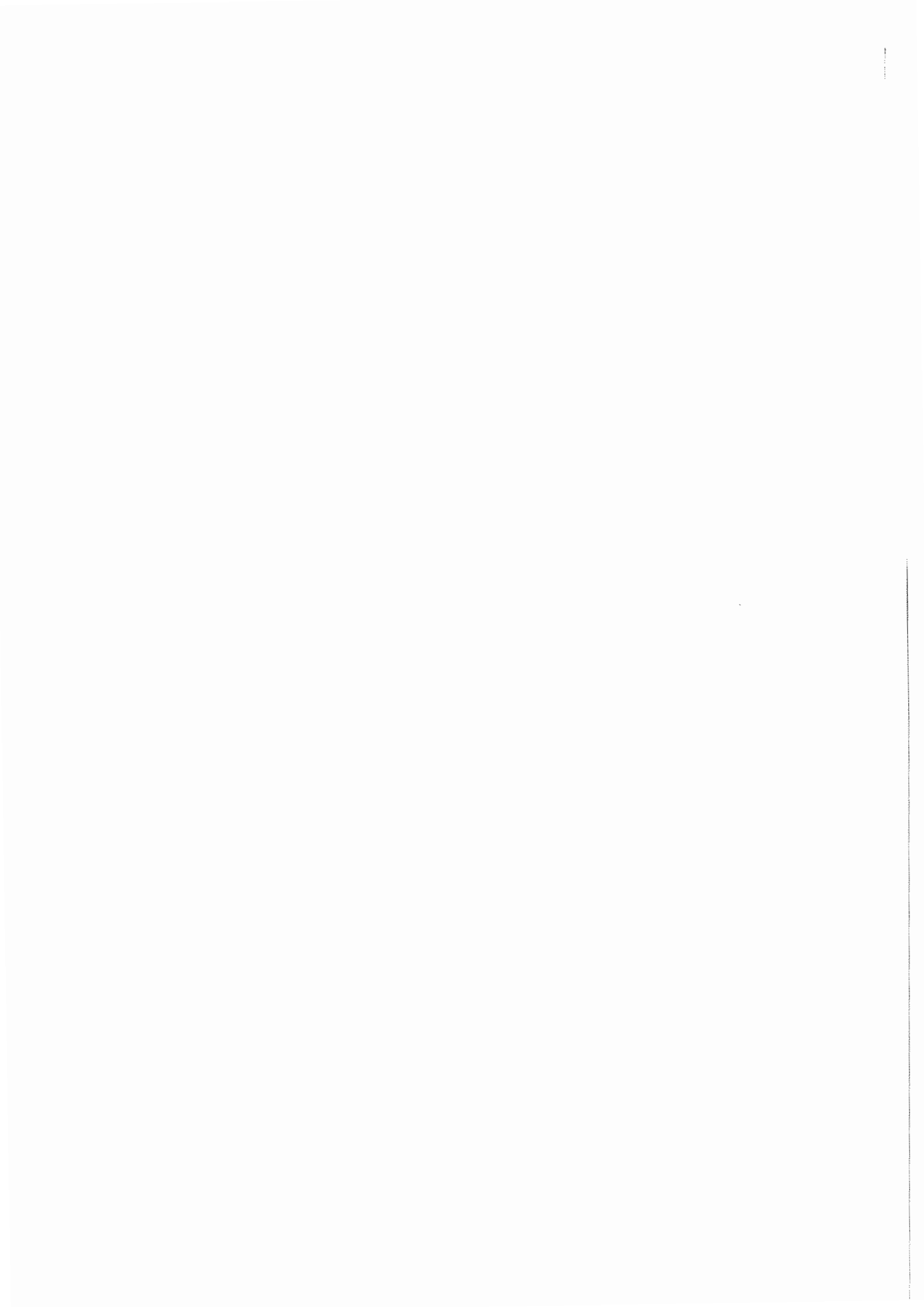
When I spoke to Ms Manning, she assured me that no changes were planned in the near future. However, the genie is out of the bottle and it is the SSSC that will be left to handle the questions and uncertainties both for the sector and for our own staff. This could so easily have been avoided. There has been plenty opportunity for officials to communicate directly with me or my colleagues, or through our sponsor team. Our then Minister, Mark MacDonald came to meet with our Council Members last week and didn't mention this at all, which makes me wonder if even he was aware of it.

I hope you will recognise why I'm so disappointed and taken aback by this and that things will change in the future.
