To clarify my earlier request, I respectfully ask that you perform a search for all correspondence—including text messages—containing anywhere in the document (1) the name “Roberta F. White” and (2) one or more of the additional search terms I supplied in my initial request (Ramazzini Institute, BRI, Linda Birnbaum, etc.).

In other words, please do not simply perform a search of any employment database you may have or email account that Roberta F. White may have, but use “Roberta F. White” as a search term to be run across all records that HHS retains.

In the event that these searches do not result in any records, we ask that you perform a final terms and connectors search for all correspondence—including text messages—containing anywhere in the document (1) the search term Roberta /3 White (i.e., Roberta
