Dear Mr. Evers:

This letter is in response to your Freedom of Information Act (FOIA) request dated February 27, 2018. Your request was received in the Departments of Housing and Urban Developments' FOIA Branch on February 28, 2018. You are requesting the following information:

1. All SF-50 (Notification of Personnel Action) forms related to Helen Foster that relate to a change in position or title;
2. Records sufficient to show official titles and duties of Helen Foster, including all position descriptions;
3. All SF-50 (Notification of Personnel Action) forms related to Maren Kasper that relate to a change in position or title; and
4. Records sufficient to show official titles and duties of Maren Kasper, including all position descriptions.

Your request is granted in part at no cost to you. Enclosed are the documents pertaining to your request. I am withholding the Social Security numbers, dates of birth and the employee data pursuant to FOIA Exemption 6. Exemption 6 protects information that would constitute an unwarranted invasion of personal privacy. The interest of the general public on reviewing these portions of government documents not outweigh the individuals' right to privacy.

I am the official responsible for this determination based on information provided by the Department's Office of Human Resources. You may appeal this determination within 90 days from the date of this letter. If you decide to appeal, your appeal should include a copy of your original FOIA request, a copy of this response as well as a summary of the reasons supporting the appeal. With regards to Exemption 6, your appeal should address the nature of the overriding public interest in disclosure that outweighs the personal privacy interest protected by the exemption. The envelope should be plainly marked to indicate that it contains a FOIA appeal and be addressed to:


