Dear Mr. Mulvey:

This is the final response, to your September 7, 2017, Freedom of Information Act (FOIA) appeal to the U.S. Department of Agriculture (USDA), Departmental FOIA Office (DFO). Your enclosed request sought copies of the Internet browsing histories of Secretary Sonny Perdue and the USDA Director of Communications, from January 20, 2017 to the present, or the period reflecting the entire browsing histories retained for both Secretary Perdue and the Director of Communications.

Additionally, you expressed interest in receiving the browsing activity on all government-issued, Internet-connected devices, including desktop and laptop computers, cellular telephones, and tablet devices, and to the extent multiple Internet browsers are installed on each device, you requested records of the browsing activity on each application.

On August 30, 2017, the DFO responded to your request. On September 7, 2017, you filed the enclosed appeal challenging its determination that an employee's internet browsing history activity does not qualify as an agency record. After careful consideration of your appeal in its entirety, a determination has been made to uphold the DFO's initial determination. Accordingly, no additional searches were initiated.

As stated previously, this is the final response letter to your appeal. If you are dissatisfied with this decision, you may seek judicial review in the Federal District Court.

Prior to seeking judicial review, you may want to contact the Office of the Government Information Services (OGIS). As part of the 2007 FOIA amendments, OGIS was created to offer mediation series to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to Ryan Mulvey 2017-OCIO-00341-A
