I don't know why is the FBI or USCIS putting so much delays on my case. I was only 18 years old when I got deployed and was I was 20 when I returned from deployment. 

I apologize for taking your time, but certain circumstances have forced me to inform my House Of Representative Duncan Hunter, California Senators Kamala Harris and Dianne Feinstein, California Governor Jerry Brown, and San Diego City Mayor Kevin Faulconer about an issue for which both me and my wife seem to be given a runaround for more than three months now. At this moment, it is as if my wife does not have a legal status to be in USA because her conditional Permanent Resident Alien expired in November 2017. I, George Vukovich, have lived legally in United States since 1988, have lived almost my entire life in San Marcos, CA and am a US Citizen since 2002.

According to the USCIS rules, I and my wife, whom I have met in 2013, have applied for my wife to enter United States through K-1 visa. At that time, there were no issues whatsoever and she was able to enter United States in February 2014 on K-1 visa. As required by the USCIS rules for K-1 (fiancé visa), we were married in March 2014, 6 weeks earlier than the expiration of 3 months. Immediately, we sent and completed paperwork to the USCIS, included the necessary fees. During the interview at USCIS office in downtown San Diego, there was only one issue, which was quickly resolved and my wife received her conditional Resident Alien Card (valid for two years) within two weeks of that interview. Although we had a civil marriage in county clerk's office in San Marcos, we also had a church wedding service in February 2015, as per our traditions. Our son Milutin was born in November 2015.

As my wife's conditional resident alien status was approaching its expiration, we completed and sent all the forms necessary and paid the fees to the USCIS. On November 18, 2016, we received the I-797 (Notice of Action) letter confirming that USCIS has received the letter, her legal status has been extended for an additional year and that we should be receiving a letter for a biometrics scan appointment. For over a year, nothing was received from USCIS.

On January 12<sup>th</sup>, 2018, I and my wife decided to call the USCIS hotline to find if there were any issues. We were informed that they did send the letter for a biometrics scan appointment. We explained that there were no letters received from USCIS since November 2016. Once again, USCIS officer informed us that they will send a letter for the appointment. Furthermore, USCIS office asked us to call back if we do not receive a letter to inform us for the biometrics scan appointment.

However, on January 27, 2018, my wife did receive an email from USCIS which gave us the case number (WAC-17-049-00047), referral id number (T1B0121802124CSC), and informed us that it is not required that my wife Jelena to have biometrics scan done and that previous biometrics scan from 2014 will be used.

As requested from the January 12<sup>th</sup>, 2018 call to USCIS, me and my wife called the office back on Tuesday, February 22<sup>nd</sup>, 2018 to inform them that no mailed letter has been received informing us about the status. However, this time, we were told that neither the case or referral id number were valid. Furthermore, we were informed that someone will be calling us back within 24 hours. When the USCIS officer called us back, she told us that she can't help us and that the only option was to make an appointment at the local USCIS main office in downtown San Diego. When I asked for the USCIS officer's name and badge number, she did give me a name, but refused to give me her id number. However, when I explained that I could not make an appointment through InfoPass, she simply explained that I have to keep trying. Honestly, I believe that this USCIS officer, who claimed to be an upper level USCIS officer, did not know how to respond and try to put the blame on my wife Jelena and myself and that I should sit in front of an InfoPass website 24/7 until the link for scheduling an appointment was valid and working. Since I have been living in the United States for over 30 years, this seemed quite unprofessional. Instead, we decided to stop by another small USCIS office located in our own town of San Marcos (San Diego County), but were given the same answer in regards to InfoPass appointment.

As I mentioned earlier, it seems that we are given a runaround. I do understand that currently, USCIS personnel is understaffed and overworked and I beg of you not to think that I do not understand those circumstances. However, I do wish that you understand that this is putting a lot of worries on both me and my wife who have a 2 year old son and are planning to buy a house, open our own Residential Home for Elderly, increase our income (at least three fold) since 2016. We are not asking for any special treatment, but rather an explanation and promise where neither I nor my wife have to fear that she will be forced to leave United States due some mistake that was not of our own making. We have nothing to hide and do not wish that anyone hides anything from us either. We did everything according to the law from the first day in September 2013, and expect the same in return. Both me and my wife have done joint state and federal taxes since April 2015 and have paid all the dues.

If necessary, I am willing to send through mail, email, or fax copies of the I-797, Jelena Vukovich's resident alien card, recent e-mail from USCIS on January 27<sup>th</sup>, and a marriage certificate which might help you lead us towards the right way since USCIS seems not to be willing to do so, at least since this letter.

I apologize for such a long letter, but I am sure that you can understand our concern.
