STIPULATED MOTION AND  
ORDER TO REMAND

**JOINT STIPULATION**

The parties stipulate and agree that all claims in this matter can be remanded to  
U.S. Citizenship and Immigration Services (“USCIS”). Within one week of the date  
when a remand order is signed, USCIS will adjudicate plaintiff’s pending N-336, Request

1 for a hearing on a Decision in Naturalization Proceedings as well as his N-400  
2 Application for Naturalization. If plaintiff continues to maintain good moral character,  
3  
4 USCIS will schedule the Oath of Allegiance within four weeks of the date a remand order  
5 is signed.

6           Within a week after plaintiff swears the Oath of Allegiance, the parties will file a  
7 stipulation of dismissal with prejudice in which the parties agree to dismiss all claims  
8 against all defendants in this matter with prejudice and without fees or costs to either  
9 party.
