I am writing regarding Alan G. Keyes. After receiving your letter dated May 1, 1989 to Walter Johnson, I sent District Executive David Thomas to the Northwest Military and Naval Academy on an inquiry of Mr. Keyes. David was informed that Mr. Keyes had been suspended for an alleged sexual encounter with a minor.

Paul, since the suspension Mr. Keyes has left the area and is being pursued by the Walworth County Police Department. His last known residence was in the state of Illinois.

In addition to the original charges brought against Mr. Keyes, he now faces a "flight to avoid prosecution" charge in Walworth County, Wisconsin.

As recent as last week no change has occurred, no court hearing, just a growing list of criminal complaints.

I, therefore, concur with your action that Mr. Keyes not be given an opportunity to join Scouting now or in the future.

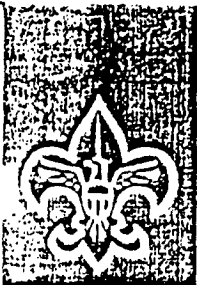

Dear Mr. Keyes:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are, therefore, compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership the Boy Scouts of America seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts, supporting your claim that your registration as a BSA member should be granted or reinstated.

The procedures for review are attached.

Alan Keyes, a registered leader in several capacities in this council, principally as assistant Scoutmaster of Troop 507, St. Margaret Mary Catholic Church, Naperville, Illinois, recently left this area to become "Youth Director" or "Program Director" at the Northwestern Military and Naval Academy in Lake Geneva, Wisconsin.

Lake Geneva is in the council headquartered in Janesville, Wisconsin.

We understand Mr. Keyes was arrested at the Academy by local authorities for sexually molesting a seventh grade student.

I have sent the usual letter suspending his registration to him at the Academy and to his former Woodridge address, requesting they be forwarded.

I happen to know that Keyes came to our council from the Kansas City area where he worked and attended school. His father and mother recently relocated from Illinois to Idaho or Montana.

I would not be surprised if he attempted to re-enter Scouting in some capacity, particularly since he cannot know that we are aware of his arrest.
