REPORT TO THE CITY COUNCIL FROM TRANSPORTATION & PUBLIC WORKS COMMITTEE July 24, 2018

A regular meeting of the committee was convened at 10:00 am on this date.

Matters listed below are hereby submitted with the following recommendations; to-wit:

1. Agreement with Minnesota Department of Transportation (MnDOT) for landscaping improvements at Highway 77 and Highway 62 interchange (2018-00875)

Authorizing a cooperative agreement with the Minnesota Department of Transportation (MnDOT), to accept up to \$5,000 in funding from the MnDOT Community Roadside Landscaping Partnership Program, for landscaping improvements within the northeast corner of interstate right-of-way at the Highway 77 and Highway 62 interchange to be installed and maintained by Nokomis East Neighborhood Association (NENA).

2. 28th Ave S Street Reconstruction Project: Minnesota Department of Transportation Miscellaneous Work on Trunk Highway Right-of-Way Permit (2018-00869)

Authorizing execution of a Minnesota Department of Transportation (MnDOT) Miscellaneous Work on Trunk Highway Right-of-Way Permit to complete portions of the 28th Ave S Street Reconstruction Project No. 6761 located within MnDOT right-of-way.

3. Contract amendment with NAC Mechanical & Electrical Services to complete condenser upgrade in the Haaf Parking Ramp (2018-00870)

Authorizing an increase to Contract No. C-43009 with NAC Mechanical & Electrical Services, in the amount of \$8,997 for a total amount not to exceed \$170,997, for upgrading old condensing equipment in the Haaf Parking Ramp.

16. Bid for structural lining of water mains (2018-00857)

Accepting the sole bid of Fer-Pal Construction USA, LLC, submitted on Official Publication No. 8589, in the amount of \$1,152,629, to provide all materials, labor, equipment, and incidentals for the structural lining of water mains for the Minneapolis Public Works Department, and authorizing a contract for the project, all in accordance with City specifications.

17. Bid for outdoor electrical switchgear (2018-00861)

Accepting the second low bid of States Manufacturing Corporation, submitted on Official Publication No. 8578, in the amount of \$406,400, to provide all materials, labor, equipment, and incidentals to furnish, deliver, and install outdoor electrical switchgear for the Minneapolis Public Works Department, and authorizing a contract for the project, all in accordance with City specifications.

18. Bid for excavation, hauling, and disposal of contaminated soils (2018-00880)

19. License agreement for shared motorized foot scooter operations (2018-00883)
