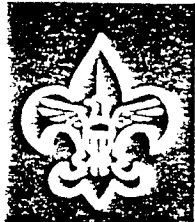

We reserve the right to refuse registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

ACCUSATION

BE IT KNOWN THAT, by this [Information] ~~[CONFIDENTIAL]~~, Investigator Joseph W. Holly,  
as the Complainant herein, [stationed] ~~[redacted]~~ at Horseheads, N.Y.,  
accuses Thomas E. Noyes  
the above mentioned Defendant(s), with having committed the ~~[redacted]~~ [misdemeanor] ~~[redacted]~~  
of Sexual Abuse in the Second Degree (2 counts), in violation of Section 130.60 subd. 2  
Subdivision 2 of the Penal Law of the State of New York.

That on or about the 20th day of November, 19 83, at about 11k [redacted] [p.m.] in the  
Town of Florida, County of Chester, the  
Defendant(s) did [intentionally,] [knowingly,] ~~[redacted]~~ and unlawfully,

person is guilty of sexual abuse in the second degree when he subjects another  
person to sexual contact and when such other person is less than fourteen years old.  
To wit: On the above mentioned dates Thomas E. Noyes an adult, DOB 10/24/60 did place his  
bare hands on the naked penis of a juvenile ~~[redacted]~~ in a sexual  
manner. These acts took place on two separate occasions, during Boy Scout Campouts  
involving Troop 15 of the Emmanuel Episcopal Church. All contrary to the statute of this  
law made and provided.

After being advised by Inv. Holly of a statement given to him by [REDACTED] regarding sexual abuse claimed by him, I give the following statement - I have been the Scout Master of Troop 15 for the past 3 years and an Asst. Scout Master for 3 years prior to that. [REDACTED] was a scout in this Troop up until the Spring of 1984, he had been in the Troop for about two years. During this time I had been his P.A.L. for about 6 months. This is designed like a big brother program. I took [REDACTED] along with several other scouts on several camps. On the two occasions in [REDACTED] statement,

the 1st in. The fall of 1983 and again in Spring of 1984 I had placed my hand on [redacted] private parts. This took place during a bed check when I would check to see if each scout was alright. I have never performed oral sex with [redacted] on any occasion. I know that it is wrong to have sexual contact with any of the boys.

In regards to the incident in February 1985 at my parents house, where I have an apartment, [redacted] had come to my house after a ~~camp~~ <sup>day</sup> outdoor activity, the Klondike Derby, at Erin Park Station and we were working on the computer. [redacted] was real tired and falling asleep on the bed, his pants and socks were wet and we removed them to keep from getting the bed wet. He didn't have sex with [redacted], my present wife, and his under pants were not removed. I placed a blanket over him, he slept about two hours and [redacted] and I took him home.

I have read this statement and it is the truth to the best of my knowledge.

This is a statement given to Investigator JOSEPH W. HOLLY, of the New York State Police by me, [REDACTED], born on [REDACTED], formerly living at [REDACTED] Elmira, New York. I give this statement to Investigator HOLLY of my own free will and without promise or threat, and I know that it is against the law to give false information to the police. I am presently a resident of the [REDACTED] [REDACTED] where I have been since 05/02/85 as I have been on probation and I had violated one of the conditions of my probation; that being that I must attend school regularly. My Probation Officer's name is THOMAS GENERAS. This statement is given in the presence of STEPHEN M. SANO, Supervisor of Detention at the Facility, in his office. On 05/07/85 I discussed the following information with a staff member at the facility ANN MILLIKEN, and I told her that on four different occasions I had been sexually molested while a member of the Boy Scouts. I decided to give this information to somebody after recently seeing articles on television about sexual abuse. Again on this date, 05/08/85, I repeated this information to STEPHEN SANO.

In the Fall of 1983, I do not remember the exact date, I was with about nine boys as a member of the Boy Scout Troop from Emmanuel Episcopal Church, Troop 15, at a campgrounds called Sarah Wells; I am not sure of the location. Our Boy Scout Leader in this troop's name is TOM NOYES. I was asleep in the middle of the night inside a cabin, when I felt someone put their hand inside of my pants and they fondled me for several minutes, during which time nothing was said. I was able to open my eyes and see that the person that was doing this to me was our leader, TOM NOYES.

In early spring, in 1984 on a week-end, I was camping with the same troop on Draght Hill in a cabin owned by Troop 15. Again, in the middle of the night I felt someone put their hand in my pants. I had been asleep, but as I awoke I was able to see that again this was TOM NOYES. Again nothing was said during the time he was fondling my privates, or afterwards.

About a month later in 1984, while camping in a tent at Roricks Glen in the middle of the night while I was sleeping, someone entered my tent and again stuck their hand into my pants. After a few minutes this person removed my pants and performed oral sex on me. I was able to see this again was our lead TOM NOYES. This person performed oral sex until I had an ejaculation, and again there was no conversation.

In early February, 1985, I do not remember the exact date, I was invited to TOM NOYES apartment, which is located in his mother's cellar someplace in West Elmira. I don't know the exact address but it is near [REDACTED] Apartments. I had gone there to be assisted by NOYES as he was helping me with my school work and we were working on a computer that I needed for a merit badge in scouting. Later that evening I had fallen asleep in the chair. I don't how long I had been asleep but I was awakened by both TOM NOYES and his girlfriend, REGINA ARNOLD, who is a deli clerk at Top's Market. She had been at this same apartment that evening helping me and TOM. They woke me up and took me to a bed where they undressed me. REGINA also undressed and she had intercourse with me on the bed, as TOM was watching. After this was over, nothing was said and I was not threatened against telling anyone.

I have been a member of Troop 15 for about three years and during this time we have gone on campouts once each month. During these camp outs I know of no occasion that any other boy/s/ was sexually approached by NOYES. Other members of Troop 15 that I know by name are as follows: [REDACTED]

I have been asked by Investigator HOLLY if anybody other than TOM NOYES has ever approached me for any sexual activity. In the Month of August, 1983, and against in August 1984, I was traveling with my father, who was working for a fair in the State of Massachusetts. At this time a man I do not know and cannot describe approached me and tried to encourage me into sexual activity. I refused this man and nothing ever happened.

I have been asked by Investigator HOLLY if I know the difference between telling the truth and telling a lie. I know that it is wrong to tell a lie; I have told lies in the past, but none of this information that I am giving today is a lie, and it is the truth to the best of my knowledge. I also know that it is against the law to sign a statement containing any false information.
