INCIDENT NARRATIVE

ON MARCH 9TH, 2007, I WAS DISPATCHED ALONG WITH UNIT 1202, OFFICER BURDINE TO A DOMESTIC CALL LOCATED AT [REDACTED] ENROUTE TO THE CALL, WE RECEIVED AN UPDATE THAT THE FEMALE HAD CUT THE MALE ON HIS HAND AND AN AMBULANCE WAS DISPATCHED TO THE SCENE. UPON ARRIVAL, I KNOCKED ON THE DOOR AND THE SUSPECT, MRS. YAMMA B-LUMAR CAME TO THE DOOR WALKING SLOW AND APPEARING TO BE IN PAIN. AS I ENTERED THE HOME, I OBSERVED THE BLOOD SPLAT AND DROPPINGS ON THE WOODEN FLOOR. MRS. LUMAR STATED THAT SHE HAD A VERBAL ALTERCATION IN THE GUEST HOUSE WITH HER HUSBAND. BOTH SUSPECTS HAD BEEN DRINKING. MRS. LUMAR STATED THAT HER NEPHEW WAS PRESENT WHEN EVERYTHING OCCURRED. MRS. LUMAR STATED THAT HER HUSBAND, MR. DARREN ANTHONY LUMAR PINNED HER UP AGAINST THE WALL IN THE GUEST HOUSE AND SHOVED HER. ACCORDING TO MRS. LUMAR, HER NEPHEW/EYE WITNESS, MR. FORLANDO BROWN ATTEMPTED TO CALM THINGS DOWN AND ESCORTED HER TO THE MAIN HOUSE, BUT MR. LUMAR FOLLOWED AND THE ALTERCATION ESCALATED. MRS. LUMAR STATED THAT HER HUSBAND WAS 6 FEET AND 3 INCHES TALL, AND THAT HE PUNCHED HER IN THE NOSE, THREW HER TO THE MARBLE FLOOR WHERE SHE HIT HER HEAD. MRS. LUMAR STATED THAT HER HUSBAND CONTINUED TO THROW HER AROUND UNTIL SHE BROKE LOOSE. MRS. LUMAR STATED THAT SHE BROKE LOOSE FROM HER HUSBAND'S PIN AND WENT TO THE KITCHEN AND RETRIEVED A BUTCHER KNIFE AND STABBED MR. LUMAR IN THE FOREARM IN SELF DEFENSE. SHE STATED THAT HER HUSBAND TOOK THE KNIFE OUT OF HER HAND AND SHE THEN CALLED 911. MRS. LUMAR DID NOT HAVE ANY PHYSICAL INJURIES ONLY COMPLAINTS. MRS. LUMAR HAD SLIGHT SWOLLEN TO THE BRIDGE OF HER NOSE. GRADY UNIT #7234 CAME TO THE SCENE AND CHECKED MRS. LUMAR OUT, BUT STATED THAT THERE WASN'T ANYTHING FOR THEM TO TREAT, BUT SUGGESTED THAT SHE GO TO THE HOSPITAL ON HER OWN TO BE CHECKED. ON THE OTHER HAND, MR. LUMAR STATED THAT THERE WAS A FAMILY DISCUSSION GOING ON BETWEEN HIMSELF, HIS WIFE, AND THE NEPHEW IN THE GUEST HOUSE. MR. LUMAR STATED THAT THE DISCUSSION TURNED INTO A VERBAL ALTERCATION AND HIS WIFE BECAME UPSET WHEN HE SIDED WITH HER NEPHEW. THE NEPHEW ATTEMPTED TO BREAK IN BETWEEN THEM, BUT WAS UNSUCCESSFUL. THE VERBAL ALTERCATION CARRIED OVER TO THE MAIN HOUSE WHERE MRS. LUMAR BECAME PHYSICAL WITH MR. LUMAR. MR. LUMAR ATTEMPTED TO RESTRAIN HER BY HOLDING HER ARMS UP AGAINST THE WALL, BECAUSE SHE HAD BEGAN BREAKING VALUABLE THAT WERE MADE OF GLASS. MRS. LUMAR BROKE FREE FROM MR. LUMAR'S HOLD AND WENT TO THE KITCHEN AND RETRIEVED THE BUTCHER KNIFE. WHEN SHE RETURNED TO HIM, HE ATTEMPTED TO RESTRAIN HER ONCE AGAIN, BUT SHE BROKE FREE AND CUT HIM ON HIS RIGHT FOREARM. MR. LUMAR GOT THE KNIFE FROM HIS WIFE AND REMOVED IT FROM THE MAIN HOUSE AND TOOK IT TO THE GUEST HOUSE. MR.

LUMAR DROVE HIMSELF TO ST. JOSEPH HOSPITAL LOCATED AT 5665 PEACHTREE DUNWOODY RD IN ATLANTA, GA. THE NEPHEW, MR. BROWN RODE ALONG WITH HIM. MR. BROWN STATED THAT MR. LUMAR NEVER STRUCK HIS WIFE AND THAT SHE SLIPPED ON THE MARBLE FLOOR AND HIT HER HEAD AND FACE ON A COLUMN IN THE HOUSE WHILE SHE WAS OUT OF CONTROL. THE COUPLE HAS TWO CHILDREN WHO WERE PRESENT IN THE MAIN HOUSE UPSTAIRS WITH THE NANNY AT THE TIME OF THE ALTERCATION. THE CHILDREN WERE TAKEN AWAY FROM THE LOCATION BY MRS. LUMAR'S MOTHER, DEIDRE JENKINS. MR AND MRS. LUMAR WERE CHARGED AND MRS. LUMAR AGREED TO LEAVE THE LOCATION FOR THE NIGHT. MR. LUMAR RECEIVED 12 STITCHES AS A RESULT OF THE STAB WOUND. UNIT 1294, SGT. WELLS, GENERAL INVESTIGATOR UNIT 4382, W. CARSTAFFIN, AND I.D TECH 7321, SMITH CAME TO THE SCENE AND ASSISTED WITH PROCESSING. THE HOUSE WAS IN DISARRAY DUE TO THE ALTERCATION.
