On 10/22/2018 I spoke by phone with Ms. Yamma Brown, who called Cobb PD Precinct 4 to report harassing communication. Ms. Brown stated that she had begun receiving phone calls and text messages the previous day from someone named Christian St. John. Ms. Brown said that St. John claimed to be a family member in posts on Twitter related to a recent event (Ms. Brown is the daughter of singer James Brown) celebrating the 50th anniversary of one of James Brown's songs. The twitter name St. John was using was @rainventerprises. Since the report was made his tweets have been removed and the twitter name is no longer valid. Ms. Brown added that she was unsure if the suspect's real name was actually Christian St. John.

Ms. Brown said that St. John somehow obtained her personal phone number and began to call her, starting at 4:46 PM on October 21. After a couple of calls which Ms. Brown answered by telling St. John that he had the wrong phone number and should not call again, St. John began texting Ms. Brown at the same number. St. John was continuing to text Ms. Brown as she made the report to me. Ms. Brown said that she did tell St. John to stop texting her as well. She added that none of the texts were threatening but at this time it was just harassing in nature.

After I completed my initial conversation with Ms. Brown I made an attempt to contact St. John at the phone number The first time the phone was answered I introduced myself and asked who I provided by Ms. Brown (was speaking with. The male who answered the phone countered by asking who I was looking for. When I said that I was attempting to speak with Christian St. John the male began to laugh and then suggested that I wanted to speak with Yamma Brown. The male then hung up. I called back and the male answered, immediately repeating that I should talk to Ms. Brown. I said that I had spoken with her and that at her request I was advising him to stop calling, texting or contacting her by any means. The male said that he did not know what I was talking about and again hung up.

I called Ms. Brown back and advised her of the results of my phone call to St. John. I suggested to Ms. Brown that she block the phone number used by St. John and that she also block him on all social media. I told Ms. Brown that she should contact the Cobb County Police Department immediately if St. John attempts to contact her again using a different phone number, e-mail or a different social media account.

I provided Ms. Brown with the case number for this report.
